RSA 105:13-d Exculpatory Evidence Schedule Compliance Report

Pursuant to RSA 105:13-d, V, the Department of Justice is required to file a quarterly report with each of you containing the following information:

(1) The total number of officers on the exculpatory evidence schedule:

There are presently 262 officers on the exculpatory evidence schedule.

(2) The number of officers who were sent notice under paragraphs II and III:

254 officers were sent notice under paragraph II of RSA 105:13-d.¹ Thirteen officers have been sent notice under paragraph III of RSA 105:13-d.

(3) The number of officers whose names have been disclosed to the public under each paragraph of RSA 105:13-d:

The names of 194 officers have been disclosed to the public pursuant to RSA 105:13-d, II.

No names have been disclosed to the public pursuant to RSA 105:13-d, III.

(4) The number of officers who have filed lawsuits under this section, including the case name, number, jurisdiction, and corresponding field on the redacted exculpatory evidence schedule indicating the officer who has filed the lawsuit.

74 officers have notified the Department of Justice that they have filed lawsuits under this section. As of the date of this report there are 58 pending lawsuits. Corresponding case information is included in the attached redacted exculpatory evidence schedule.

It is our understanding that the superior court has taken steps to seal the lawsuits that officers have brought pursuant to RSA 105:13-d. See RSA 105:13-d, V ("Nothing herein shall preclude the court from taking any necessary steps to protect the anonymity of the officer before entry of a final order."). Court staff have advised us that, generally, the only information available to the public is the pseudonymous case name, the case number, and the court in which the case is pending. However, in some matters the dockets have been unsealed. The available public information has been included in the accompanying public version of the EES.

(5) The number of people who are temporarily on the nonpublic exculpatory evidence schedule pending any grievance process:

21 officers are presently on the temporary nonpublic exculpatory evidence schedule pending any grievance process.²

¹ Those who are designated on the attached redacted EES as not yet receiving notice are either: deceased; on military deployment overseas; or this Office has been unable to obtain any contact information for the individual from the relevant law enforcement agency that last employed the individual or the Police Standards and Training Council. This Office is actively addressing these situations.

² These individuals are not included on the attached redacted EES per RSA 105:13-d. Three of these individuals have pending lawsuits that have been filed under seal.
