To whom it may concern:

Pursuant to New Hampshire's Right to Privacy Law (N.H. Rev. Stat. §359-C:20(I)(b)) on behalf of AutoNation, Inc., I am notifying you of a recent security incident that one of our third party vendors experienced, and that may have compromised some of our customers' personal information, including information for approximately 8 New Hampshire residents.

TradeMotion, which hosts and operates the https://parts.autonationfordwhitebearlake.com/ website on our behalf (including all payment functions), believes that criminal hackers were able to unlawfully access certain credit card information as it was being entered into their system during the period from March 5, 2014 to May 2, 2014. We believe the information that was accessed may have included the consumer's name, address, email address and credit card number, but are continuing to investigate which specific consumers were affected and what specific information was accessed. TradeMotion has contacted the FBI regarding this incident.

We understand from TradeMotion that it has removed the software used by the hackers to access this information and is monitoring its systems for any ongoing activity. It is also conducting penetration testing and is monitoring its systems for any additional unauthorized activity. We are working closely with TradeMotion to continue to monitor the situation.

We have notified all affected consumers of this incident, including all New Hampshire residents. Notifications to consumers were mailed on May 20, 2014. I have attached the form of letter we used to notify affected consumers.
