To Whom It May Concern:

In accordance with N.H. Rev. Stat. Ann. § 359-C:20, I am writing on behalf of the City of Roanoke, Virginia ("Roanoke") to notify you regarding the nature and circumstances of a recent data security incident. Roanoke's mailing address is at the Noel C. Taylor Municipal Building, 215 Church Avenue, Roanoke, VA 24011.

The incident was discovered on or about May 4, 2023, during a routine cybersecurity exercise. Roanoke regularly engages outside partners for penetration tests to discover potential vulnerabilities to Roanoke's systems. In this instance, the testers identified a configuration issue that might have allowed unauthorized parties to access a single Roanoke server that housed some employee pension information.

Upon discovering the vulnerability, we began an investigation and engaged leading outside cybersecurity experts to confirm that the scope of this vulnerability was limited to a single Roanoke server. The vulnerability itself was immediately remedied. We also conducted an extensive review of all files potentially exposed by the vulnerability to identify anyone who may have been impacted by this incident.

We have no evidence that any unauthorized party exploited the vulnerability to acquire personal information for any malicious purposes. Likewise, we have observed no evidence indicating cybercriminals have used any personal information stemming from this event to cause any harm, or for any malicious purpose. However, as described in detail in the attached notification letters, the vulnerability may have exposed the following types of information:

In response to this incident, we have notified the Virginia State Police's Fusion Intelligence Center. Additionally, we have arranged to provide potentially impacted individuals with of credit monitoring and identity restoration services through Experian at no cost to them.

Only 2 New Hampshire residents were potentially impacted by this incident. We worked with our outside counsel to expeditiously identify these individuals. Attached for your reference is a copy of the notice we plan to mail the impacted New Hampshire residents on July 31, 2023.

Specifically, we want to share with you how this matter may have affected your personal information and, as a precaution, to provide you with steps you can take to protect this information.

Although we have no evidence that any unauthorized party successfully removed your personal information from the vulnerable Roanoke server or is using it for a malicious purpose, we wanted to alert you to this matter.

Roanoke takes the privacy and security of your personal information very seriously and we sincerely regret any concern this incident may cause you.

What Happened and What Information Was Involved

The incident was discovered recently during a routine cybersecurity exercise. Roanoke regularly engages outside partners for penetration tests to discover potential vulnerabilities to Roanoke's systems. In this instance, the testers identified a configuration issue that might have allowed unauthorized parties to access a single Roanoke server that housed some employee pension information. We quickly engaged leading cybersecurity experts to analyze the scope of the issue and remedy the configuration issue. Once we became aware of the potential for unauthorized access, we also conducted an extensive review of all files potentially exposed by the vulnerability to identify anyone who may have been impacted by this incident.

Based on this review, we have determined that the information in the vulnerable server may have included one or more of the following types of information: your

We have no evidence that any unauthorized party ever acquired your personal information from Roanoke's system for a malicious purpose. Nonetheless, we wanted to alert you to this matter. Additionally, we have arranged for free credit monitoring out of an abundance of caution. What We Are Doing

Upon discovering the vulnerability, we began an investigation and engaged leading outside cybersecurity experts to confirm that the scope of this vulnerability was limited to a single Roanoke server. The vulnerability itself was immediately remedied.

We have no evidence to determine whether unauthorized entities were able to discover or access your information as a result of the vulnerability. We also have no evidence that any unauthorized entities used any of your personal information on the server to cause harm, or for any malicious purpose. However, out of an abundance of caution, we are notifying you of this event and are asking you to stay vigilant regarding your personal information.

We have notified the Virginia State Police's Fusion Intelligence Center of this incident and intend to support any law enforcement investigation. We take our obligation to safeguard personal information very seriously and are continuing to evaluate additional actions to strengthen our network security in the face of an ever-evolving cyber threat landscape.

You may want to order copies of your credit reports and check for any bills that you do not recognize. If you find anything suspicious, call the credit reporting agency at the phone number on the report. Keep a copy of this notice for your records in case of future problems with your records.
