Re: Notice of Data Security Incident

Dear Sir or Madam:

We write on behalf of CorrectCare Integrated Health, LLC ("CorrectCare") to notify you of a data security incident recently experienced by CorrectCare and the steps we have taken in response.

On July 6, 2022, CorrectCare, a third-party health administrator, discovered that two file directories on a web server had been inadvertently exposed to the public internet. The file directories contained personal information for certain individuals who received medical care while incarcerated at correctional facilities operated by covered entity clients of CorrectCare. Upon discovery of the data exposure, CorrectCare took immediate steps to remediate the situation and secured the server in less than nine hours. On September 1, 2022, a forensic investigation conducted by a cybersecurity firm hired by CorrectCare revealed that patient information contained in the two file directories at issue may have been accessible on the public internet as early as January 22, 2022. Based on the results of its investigation, CorrectCare believes that the information of 391 New Hampshire residents was exposed in this incident.

During normal operations, information on CorrectCare's server is protected by username and password authentication. In this incident, a misconfigured network server, not a malicious cyberattack by a threat actor, exposed patient data to the public internet.

Based on its investigation, CorrectCare has no reason to believe any affected person's information has been misused as a result of this exposure. However, out of an abundance of caution, CorrectCare is making available 12 months of identity protection services from Experian at no cost to the affected individuals.

Dear Sample A. Sample:

We are writing to inform you of an incident (Incident) involving the potential exposure of electronic files that may have included your Protected Health Information (PHI) and Personal Identifying Information (PII). As a precaution, we are providing this notice and outlining some steps we are taking to address the incident, mitigate the risk, and make specific services available to you to protect your information. We sincerely apologize for any inconvenience or concern this may cause you.

What Happened

On July 6, 2022, we discovered that two file directories on a web server had been inadvertently exposed to the public internet. The CorrectCare team quickly remediated the Incident and secured the file directories within nine hours. CorrectCare also promptly engaged a third-party cybersecurity firm to conduct an investigation to analyze the nature and scope of the Incident, and to determine whether any patient information may have been exposed. You are receiving this notice because CorrectCare determined that your information was among the information that was exposed.

What Information Was Involved

Although CorrectCare remediated this exposure in less than nine hours, further investigation revealed that patient information contained in these file directories may have been exposed as early as January 22, 2022, and thereby subject to unauthorized access. The patient information contained in the folders included

. While CorrectCare has no reason to believe that any patient's information has been misused, we are nonetheless notifying all affected patients out of an abundance of caution.

What We Are Doing

We take the protection of your personal information seriously and we have taken and will continue to take steps to prevent a similar occurrence. We have been working with outside cybersecurity experts and have implemented specific steps to safeguard against future exposure of personal information.

Monitor Your Accounts

We recommend that you regularly review statements from your accounts and periodically obtain your credit report from one or more of the national credit reporting companies. When you receive your credit reports, review them carefully. Look for accounts or creditor inquiries that you did not initiate or do not recognize. Look for information, such as home address and Social Security number that is not accurate. If you see anything you do not understand, call the credit reporting agency at the telephone number on the report.

Credit Freeze

You have the right to put a security freeze, also known as a credit freeze, on your credit file, so that no new credit can be opened in your name without the use of a Personal Identification Number (PIN) that is issued to you when you initiate a freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to access your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. Should you wish to place a credit freeze, please contact all three major consumer reporting agencies listed below.

You must separately place a credit freeze on your credit file at each credit reporting agency. The following information should be included when requesting a credit freeze:

- Full name, with middle initial and any suffixes;
- Social Security number;
- 3) Date of birth (month, day, and year);
- 4) Current address and previous addresses for the past five (5) years:
- 5) Proof of current address, such as a current utility bill or telephone bill;
- 6) Other personal information as required by the applicable credit reporting agency;

If you request a credit freeze online or by phone, then the credit reporting agencies have one (1) business day after receiving your request to place a credit freeze on your credit file report. If you request a lift of the credit freeze online or by phone, then the credit reporting agency must lift the freeze within one (1) hour. If you request a credit freeze or lift of a credit freeze by mail, then the credit agency must place or lift the credit freeze no later than three (3) business days after getting your request.

Fraud Alerts

You also have the right to place an initial or extended fraud alert on your file at no cost. An initial fraud alert lasts 1-year and is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting 7 years. Should you wish to place a fraud alert, please contact any one of the agencies listed below. The agency you contact will then contact the other two credit agencies.

Monitor Your Personal Health Information

You may want to order copies of your credit reports and check for any medical bills that you do not recognize. If you find anything suspicious, call the credit reporting agency at the phone number on the report. Keep a copy of this notice for your records in case of future problems with your medical records. You may also want to request a copy of your medical records from your provider, to serve as a baseline. If you are a California resident, we suggest that you visit the website of the California Office of Privacy Protection at www.privacy.ca.gov to find more information about your medical privacy.
