Re: Supplemental Notice of Data Event

To Whom It May Concern:

We continue to represent Cumberland Advisors, Inc. ("Cumberland") located at 2 North Tamiami Trail, Suite 303, Sarasota, FL 34236. We are writing to supplement our December 20, 2023 notification to your office regarding an incident that may affect the security of certain personal information relating to an additional twenty-eight (28) New Hampshire residents. Our previous notification to your office is attached as *Exhibit AA*. This notice will be supplemented with new significant facts learned subsequent to its submission. By providing this notice, Cumberland does not waive any rights or defenses regarding the applicability of New Hampshire law, the applicability of the New Hampshire data event notification statute, or personal jurisdiction.

Nature of the Data Event

On September 5, 2023, Cumberland discovered suspicious activity related to an employee email account. Cumberland immediately launched an investigation, with the assistance of third-party forensic specialists, to determine the nature and scope of the activity. Cumberland's investigation determined that there was unauthorized access to two (2) employee email accounts between August 31 and September 5, 2023. Therefore, Cumberland undertook a comprehensive and time-intensive review of the contents of the email accounts to determine what information was contained therein and to whom it related. It is important to note that the unauthorized access was limited to two (2) email accounts and that there was no access to Cumberland's core portfolio management system. On November 20, 2023, Cumberland finalized this review and determined that information related to New Hampshire residents may have been impacted. The information that could have been subject to unauthorized access includes

As Cumberland does not own some of the data at issue, Cumberland provided notice of the incident to appropriate data owners after its review was completed, and offered to provide notices on their behalf to

individuals and regulators. Since providing its initial notice, Cumberland continued to work with data owners and is now providing notice on certain data owners' behalf.

Notice to New Hampshire Residents

On February 14, 2024, Cumberland provided written notice of this incident to an additional twenty-eight (28) New Hampshire residents. In total, Cumberland provided notice to thirty (30) New Hampshire residents in relation to this event. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit BB***.

Other Steps Taken and To Be Taken

Upon discovering the event, Cumberland moved quickly to investigate and respond to the incident, assess the security of its systems, and identify potentially affected individuals. Further, Cumberland notified federal law enforcement and implemented additional safeguards. Cumberland is providing individuals whose personal information was potentially affected by this incident access to credit monitoring services for through Experian.

Additionally, Cumberland is providing potentially impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. Cumberland is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Cumberland is providing written notice of this incident to relevant state regulators and to the three major consumer credit reporting agencies, Equifax, Experian, and TransUnion.

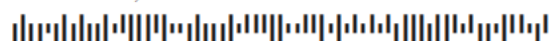

On November 20, 2023, we finalized this review and determined that information related to you was identified within the impacted accounts.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Consumers may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
