Re: **Supplemental Notice of Data Event**

Dear Sir or Madam:

We continue to represent Eileen Fisher, Inc. ("Eileen Fisher") located at 2 Bridge Street, Suite 230, Irvington, New York 10533, and are writing to supplement our December 27, 2021, notice to your office (the "December 2021 Notice"). This notice is attached hereto as *Exhibit A*. The investigation into this matter is ongoing, and this notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Eileen Fisher does not waive any rights or defenses regarding the applicability of New Hampshire law, the applicability of the New Hampshire data event notification statute, or personal jurisdiction.

Nature of the Data Event

On or about October 14, 2021, Eileen Fisher learned of suspicious activity on its computer network. Eileen Fisher immediately secured its network and launched an investigation with the assistance of third-party computer specialists to determine the nature and scope of the incident. The investigation initially determined that certain files on Eileen Fisher's systems that contain information related to employees and former employees may have been subject to unauthorized access and/or acquisition between October 11, 2021 and October 14, 2021. Eileen Fisher later learned that those files may have been subject to unauthorized access and/or acquisition between July 2, 2021 and October 19, 2021.

Eileen Fisher began notifying individuals as information became available beginning on December 23, 2021. On or around January 5, 2023, Eileen Fisher completed its most recent review effort and determined that the information that could have been subject to unauthorized access includes name and Social Security number.

Notice to New Hampshire Residents

As noted above, on December 23, 2021, Eileen Fisher began providing written notice to potentially impacted individuals about this incident. This notice included notice to two (2) New Hampshire residents. On March 1, 2023, Eileen Fisher continued providing notice of this incident to potentially impacted

individuals including two (2) New Hampshire residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit B*. The total number of New Hampshire residents notified of this incident is four (4).

Other Steps Taken and To Be Taken

Upon discovering the event, Eileen Fisher moved quickly to investigate and respond to the incident, assess the security of Eileen Fisher systems, and identify potentially affected individuals. Eileen Fisher is also working to implement additional safeguards and training to its employees. Eileen Fisher is providing access to credit monitoring services for twenty-four (24) months, through Kroll, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals. Finally, Eileen Fisher reported the incident to law enforcement and is cooperating with the investigation.

Additionally, Eileen Fisher is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. Eileen Fisher is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Eileen Fisher is providing written notice of this incident to relevant state regulators, as necessary.

("Eileen Fisher") located at 2 Bridge Street, Suite 230, Irvington, New York 10533, and are writing to notify your office of an incident that may affect the security of some personal information relating to two (2) New Hampshire residents. The investigation into this matter is ongoing, and this notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Eileen Fisher does not waive any rights or defenses regarding the applicability of New Hampshire law, the applicability of the New Hampshire data event notification statute, or personal jurisdiction.

Nature of the Data Event

On or about October 14, 2021, Eileen Fisher learned of suspicious activity on its computer network. Eileen Fisher immediately secured its network and launched an investigation with the assistance of third-party computer specialists to determine the nature and scope of the incident. The investigation determined that certain files on Eileen Fisher's systems that contain information related to employees and former employees may have been subject to unauthorized access and/or acquisition between October 11, 2021 and October 14, 2021.

The information that could have been subject to unauthorized access includes name, Social Security Number, and bank account information.

Eileen Fisher, Inc. ("Eileen Fisher") is writing to make you aware of an incident that may affect the security of some of your information. While we are not aware of any actual or attempted misuse of your information, we are providing you with an overview of the incident, our ongoing response, and resources available to you right now to help protect your information, should you feel it is appropriate to do so.

What Happened? On October 14, 2021, Eileen Fisher learned of suspicious activity on its computer network. We immediately secured our network and launched an investigation with the assistance of third-party computer specialists to determine the nature and scope of the incident. The investigation determined that certain files on Eileen Fisher's systems that contain information related to employees and former employees may have been subject to unauthorized access and/or acquisition between October 11, 2021 and October 14, 2021. While there is no indication that your specific information was accessed or misused, in an abundance of caution we are notifying you now about the incident and the services available to you that are detailed below.

What Information Was Involved? The information that may have been impacted by this incident includes your name, Social Security Number, and bank account information.

What We Are Doing. Eileen Fisher takes this incident and security of your information seriously. Upon discovering this incident, we immediately took steps to review and reinforce the security of our computing environment. We are reviewing our security policies, procedures, and processes, adding to our security systems, and rolling out additional workforce training to reduce the likelihood of a similar future incident. We have reported the incident to law enforcement and are cooperating with their investigation. We will also notify applicable regulatory authorities, as required by law.

As an added precaution, we are also offering 24 months of complimentary access to credit monitoring services, which include triple bureau credit monitoring, access to a dedicated call center, fraud consultation, and identity theft restoration, through Kroll. Individuals who wish to receive these services must activate by following the instructions found in the enclosed *Steps You Can Take to Help Protect Personal Information*.

The investigation determined that there was unauthorized access to certain employee email accounts from on or around July 2, 2021 until October 19, 2021. We reviewed these accounts, and we determined that the accessed emails and attachments contained information relating to individuals. The investigation could not confirm what specific information within the accounts may have been accessed by the unauthorized individual. Therefore, in an abundance of caution, we undertook a diligent and comprehensive review of the entire contents of the impacted accounts to determine the information present in the accounts and potentially subject to unauthorized access. This resulted in the determination that your information was included in the impacted accounts. We then reviewed our records to identify contact information for potentially impacted individuals in order to provide this notice. On January 5, 2023, we completed our review. While there is no indication that your specific information was accessed or misused, in an abundance of caution we are notifying you now about the incident and the services available to you that are detailed below.
