RE: Data Breach Notification

To Whom It May Concern:

We serve as counsel for Financial Asset Management Systems ("FAMS") located at 665 Molly Lane, Suite 110, Woodstock, GA 30189 and write to supplement our September 29, 2023, notification of a recent data breach. FAMS is a financial debt collection company that aides in collecting debts for several entities. FAMS works with its business partners, including Loan Science, LLC to provide these services. By providing this notice, FAMS does not waive any rights or defenses under New Hampshire law, including the data breach notification statute.

On March 31, 2023, FAMS experienced a network disruption and immediately began an investigation, which included working with third-party specialists. The investigation determined that certain information stored on FAMS's network was accessed by an unauthorized party. Therefore, FAMS conducted a comprehensive review of the information potentially impacted. On July 6, 2023, FAMS received initial results of the data review, which did not include any address information for potentially impacted individuals. Therefore, FAMS conducted additional data review to identify address information and completed this review on August 31, 2023. On September 5, 2023, FAMS began notifying its affected clients, which included Loan Science, LLC. On October 25, 2023, Loan Science, LLC requested FAMS provide notice of this incident on its behalf. FAMS identified approximately one New Hampshire resident associated with Loan Science, LLC who may have been impacted by this incident. The comprehensive data review determined the type of information stored on FAMS network and potentially affected included the individual's

On October 31, 2023, FAMS provided written notice to the potentially impacted individuals via U.S. mail. A copy of the notice is attached as *Exhibit A*. In an abundance of caution, FAMS is offering the potentially impacted individuals complimentary credit monitoring and identity protection services. Additionally, in response to this incident, FAMS conducted an investigation, notified the FBI, changed network passwords, and reviewed its policies and procedures related to data protection.

Financial Asset Management Systems ("FAMS") provides financial collection services for certain entities, including Loan Science, LLC. We write to notify you of an incident that may affect the privacy of your information. This letter includes information about the incident, our response, and resources we are making available to you.

On March 31, 2023, we experienced a network disruption that impacted our ability to access certain files on our network. We immediately reported the incident to law enforcement and began working with computer specialists to determine what occurred. Our investigation determined that certain information stored on our network was acquired by an unauthorized party. Therefore, we conducted a comprehensive review of the information potentially impacted. On August 31, 2023, we completed our review and began notifying our affected clients. On October 25, 2023, Loan Science, LLC requested we provide notice of this incident to you on its behalf. Our comprehensive data review determined the type of information stored on our network and potentially affected included your

Upon discovering this incident, we immediately began an investigation and also notified law enforcement. We also reviewed our policies and procedures. In an abundance of caution, we are providing potentially impacted individuals access to complimentary credit monitoring and identity protection services. We encourage you to enroll in the services we are making available to you. Information about how to enroll in these services along with additional resources available to you are included in the attached *Steps You Can Take to Protect Your Information*.

STEPS YOU CAN TAKE TO PROTECT YOUR INFORMATION

Enroll in Credit Monitoring / Identity Protection

In response to the incident, we are providing you access to credit monitoring/identity protection services at no charge. These services provide you with alerts for _____ from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided by Cyberscout through Identity Force, a TransUnion company.

To enroll in these services at no charge, please log on to <https://secure.identityforce.com/benefit/fams> and follow the instructions provided. When prompted please provide the following unique code to receive services:

In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

Monitor Your Accounts

We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your credit reports/account statements and explanation of benefits forms for suspicious activity and to detect errors. Under U.S. law, you are entitled to one free credit report annually from each of the three major credit reporting bureaus, TransUnion, Experian, and Equifax. To order your free credit report, visit www.annualcreditreport.com or call 1-877-322-8228. Once you receive your credit report, review it for discrepancies and identify any accounts you did not open or inquiries from creditors that you did not authorize. If you have questions or notice incorrect information, contact the credit reporting bureau.

You have the right to place an initial or extended fraud alert on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any of the three credit reporting bureaus listed below.

As an alternative to a fraud alert, you have the right to place a credit freeze on a credit report, which will prohibit a credit bureau from releasing information in the credit report without your express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., III, etc.);
2. Social Security number;
3. Date of birth;
4. Address for the prior two to five years;
5. Proof of current address, such as a current utility or telephone bill;
6. A legible photocopy of a government-issued identification card (e.g., state driver's license or identification card); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft, if you are a victim of identity theft.

Additional Information

You can further educate yourself regarding identity theft, fraud alerts, credit freezes, and the steps you can take to protect your personal information by contacting the credit reporting bureaus, the Federal Trade Commission (FTC), or your state Attorney General. The FTC also encourages those who discover that their information has been misused to file a complaint with them. You have the right to file a police report if you ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, you will likely need to provide some proof that you have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement, your state Attorney General, and the FTC. This notice has not been delayed by law enforcement.

Further, pursuant to the Fair Credit Reporting Act: (i) the consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information; (ii) the consumer reporting agencies may not report outdated negative information; (iii) access to your file is limited; (iv) you must give consent for credit reports to be provided to employers; (v) you may limit "prescreened" offers of credit and insurance you get based on information in your credit report; (vi) and you may seek damages from violators. You may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
