Re: Notice of Security Breach

Ms. Ayotte:

Please accept this letter on behalf of Fox Entertainment Group (the "Company") in compliance with New Hampshire Statute § 359, as notification of a data security breach that may have compromised the personal information of approximately ten (10) New Hampshire residents.

We recently became aware of an incident in which certain confidential employee information (including name, social security number and certain compensation information) was acquired by an employee of the Company's benefits department (whose employment has since ended) without the Company's authorization. We have no evidence to suggest that this personal information was disseminated by the employee to any third party or otherwise misused.

The Company reported the conduct to law enforcement and is fully cooperating with such authorities. In that regard, we have been informed that law enforcement arrested the former employee and that the individual remains in police custody. Law enforcement also executed a search warrant at the former employee's house at the time of the arrest and successfully retrieved data that had been acquired without authorization.

Attached please find a copy of the written notification that will be sent to all of the Company's current and former employees whose personal information may have been compromised, including residents in New Hampshire. The notice will also be mailed to all impacted employees, too.

WHAT YOU CAN DO

1. Remain vigilant for incidents of fraud or identity theft. Closely review your account statements, credit card bills, and credit report for unauthorized activity over the next year. Be sure to promptly report any fraudulent or suspicious activity to your local law enforcement agency, the U.S. Federal Trade Commission (1-877-ID-THEFT (1-877-438-4338)), and your financial institutions.
2. Place a "fraud alert" on your credit file. This is a simple and quick and free process that lets creditors know to contact you before opening new accounts. A fraud alert lasts for 90 days (and may be renewed). To place a fraud alert on your credit file, you can simply call or write to any of the three national credit reporting agencies (which will then notify the other two):

3. You can also put a "security freeze" on your credit file, which prohibits a credit reporting agency from releasing information from your credit report without your authorization. More information about security freezes may be found on the websites of the three national reporting agencies (provided above). To place a security freeze on your file, you must send a request to each of the three national reporting agencies at the following addresses:

4. Obtain and review a copy of your consumer credit report. Under federal law you are entitled to a free copy of your credit report each year. You may request your free consumer credit report by visiting www.annualcreditreport.com or by calling 1-877-FACTACT (1-877-322-8228).

When you receive your report, review it for anything unusual or inaccurate (e.g., accounts you did not open or inquiries from creditors that you did not initiate). If you see anything you do not understand, call the credit agency at the telephone number on the report. If you find suspicious activity on any report, you should contact your local police or sheriff's office; in most jurisdictions the person answering the phone will be able to help you make a report. In Los Angeles, once a report is filed the matter will be handled by the police department's commercial crimes unit. **Please let a manager in Human Resources know if you file a report with the police.** You should request a copy of the police report in the event you need to give copies to your creditors to clear up your records. 5. Even if you do not find any irregularities or evidence of fraud on your credit reports, for California residents the California Office of Privacy Protection recommends that you check those reports periodically over the next year. For more information you can contact the California Office of Privacy Protection at 1-866-785-9663 or you can visit the website at www.privacy.ca.gov. If you reside outside California, you may wish to contact the Attorney General's office in your state, which may have additional information for you regarding identity theft issues (including how to report suspected incidents of identity theft) in your state.

Because your confidential information was acquired in California, please be advised that you are a victim of the conduct and have certain rights under California law. A description of those rights can be found at <http://da.lacounty.gov/vwap/victimrights.htm>.
