Matter : Data Security Incident

Dear Attorney General:

The Heritage Group ("THG") with respect to a potential data security incident described in more detail below. THG takes the security and privacy of the information in its control seriously, and has taken steps to prevent a similar incident from occurring in the future.

This letter will serve to inform you of the nature of the security breach, the number of New Hampshire residents that were potentially affected, what information has been compromised, and the steps that THG is taking to secure the integrity of its systems. We have also enclosed hereto samples of the notifications made to the potentially impacted individuals, which includes an offer of free credit monitoring.

1. Nature of the Security Incident

On January 17, 2023, The Heritage Group ("THG") detected and stopped a ransomware incident mid-attack. Upon detection, THG immediately took steps to secure its network and engaged a specialized third-party forensic incident response firm to assist with securing and restoring the network environment and determining the extent of the compromise.

A comprehensive investigation revealed that the threat actor was able to exfiltrate data before the system was shut off. Extensive data mining efforts were required to identify any potentially compromised personal data. Data mining was completed on April 19, 2023, wherein it was determined that the following information for prospective, current, or former employees, or the dependents of a current or former employee was potentially compromised:

. Notably, the types of information affected were different for each individual, and not every individual had all the above listed elements exposed. All individuals were notified on May 1, 2023.

As of this writing, THG is unaware of any misuse of personal information.

2. New Hampshire Residents Notified

One (1) New Hampshire resident was potentially affected by this security incident. A notification letter was mailed to the potentially impacted individual on May 1, 2023, by first class mail. A sample copy of the notification letter is included with this letter.

3. Steps Taken

Although THG is not aware of any evidence of misuse of personal information, THG has extended to the potentially impacted individual an offer for free credit monitoring and identity theft protection through Sontiq. This service will include 12 months of credit monitoring, along with a fully managed identity theft recovery service, should the need arise. THG has changed passwords, strengthened password requirements, and implemented multi-factor authentication.

Notice of Data Incident

Dear ,

The Heritage Group is writing to inform you of a recent data security incident that may have resulted in unauthorized access to your personal information. You are receiving this letter because you were a prospective, current, or former employee, or a dependent of a current or former employee. The Heritage Group is a collection of companies including Asphalt Materials, Heritage Environmental Services, Heritage Interactive Services, Rineco, Rineco Transportation, Heritage Transportation, Heritage Thermal Services, US Aggregates, and Western States Asphalt. The Heritage Group takes your privacy and security seriously. As such, this letter contains details about the incident and resources to help protect your personal information going forward.

What Happened:

In January 2023, The Heritage Group detected and stopped a network security incident that involved an unauthorized party gaining access to our network environment. Upon detecting the incident, The Heritage Group promptly engaged third-party forensic specialists to assist us with securing the network environment and investigating the extent of unauthorized activity.

While we have found no evidence that your information has been specifically misused, it is possible that the following personal information could have been acquired by an unauthorized third party: , . We maintain this information for administrative, payroll, and human resources purposes.

What We Are Doing:

Data security is among The Heritage Group's highest priorities, and we are committed to doing everything we can to protect the privacy and security of the personal information in our care. We have made immediate enhancements to our systems, security and practices. Additionally, we have engaged appropriate experts to assist us in conducting a full review of our security practices and systems to ensure that enhanced security protocols are in place going forward. We are committed to helping those people who may have been impacted by this unfortunate situation.

Additionally, in response to the incident, we are providing you with access to Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score services at no charge. These services provide you with alerts for twenty-four months from the date of enrollment when changes occur to your

credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided by Cyberscout through Identity Force, a TransUnion company specializing in fraud assistance and remediation services.

What You Can Do:

To enroll Credit Monitoring services no charge, please log on at land follow the instructions provided. When prompted please provide the following unique code to receive services: . In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

You will need to reference the enrollment code above when calling or enrolling online, so please do not discard this letter.

We encourage you to take full advantage of this service offering. Enclosed you will find additional materials regarding the resources available to you, and the steps you can take to further protect your personal information.

Cyberscout representatives have been fully versed on the incident and can answer questions or concerns you may have regarding protection of your personal information. Please call

Additional Information

Credit Reports: You may obtain a copy of your credit report, free of charge, whether or not you suspect any unauthorized activity on your account. You may obtain a free copy of your credit report from each of the three nationwide credit reporting agencies. To order your free credit report, please visit www.annualcreditreport.com, or call toll-free at 1-877-322-8228. You can also order your annual free credit report by mailing a completed Annual Credit Report Request Form (available at https://www.consumer.ftc.gov/articles/0155-free-credit-reports) to: Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA, 30348-5281.

Security Freeze: You also have the right to place a security freeze on your credit report. A security freeze is intended to prevent credit, loans, and services from being approved in your name without your consent. To place a security freeze on your credit report, you need to make a request to each consumer reporting agency. You may make that request by certified mail, overnight mail, regular stamped mail, or by following the instructions found at the websites listed below. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse or a minor under the age of 16, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. As of September 21, 2018, it is free to place, lift, or remove a security freeze. You may also place a security freeze for children under the age of 16. You may obtain a free security freeze by contacting any one or more of the following national consumer reporting agencies:

Fraud Alerts: You can place fraud alerts with the three credit bureaus by phone and online with:

- Equifax (https://assets.equifax.com/assets/personal/Fraud-Alert Request Form.pdf);
- TransUnion (https://www.transunion.com/fraud-alerts); or
- Experian (https://www.experian.com/fraud/center.html).

A fraud alert tells creditors to follow certain procedures, including contacting you, before they open any new accounts or change your existing accounts. For that reason, placing a fraud alert can protect you, but also may delay you when you seek to obtain credit. As of September 21, 2018, initial fraud alerts last for one year. Victims of identity theft can also get an extended fraud alert for seven years. The phone numbers for all three credit bureaus are at the bottom of this page.

Monitoring: You should always remain vigilant and monitor your accounts for suspicious or unusual activity.

File Police Report: You have the right to file or obtain a police report if you experience identity fraud. Please note that in order to file a crime report or incident report with law enforcement for identity theft, you will likely need to provide proof that you have been a victim. A police report is often required to dispute

fraudulent items. You can generally report suspected incidents of identity theft to local law enforcement or to the Attorney General.

FTC and Attorneys General: You can further educate yourself regarding identity theft, fraud alerts, security freezes, and the steps you can take to protect yourself, by contacting the consumer reporting agencies, the Federal Trade Commission, or your state Attorney General.

The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them. You have the right to file a police report if you ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, you will likely need to provide some proof that you have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement. This notice has not been delayed by law enforcement.

For New Mexico residents, you have rights pursuant to the Fair Credit Reporting Act, such as the right to be told if information in your credit file has been used against you, the right to know what is in your credit file, the right to ask for your credit score, and the right to dispute incomplete or inaccurate information. Further, pursuant to the Fair Credit Reporting Act, the consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to your file is limited; you must give your consent for credit reports to be provided to employers; you may limit "prescreened" offers of credit and insurance you get based on information in your credit report; and you may seek damages from violators. You may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
