Re: Notice of Data Event

Dear Sir or Madam:

We represent Holmes Community College ("HCC") located at P.O. Box 399, Goodman, Mississippi, 39079, and are writing to notify your office of an incident that may affect the security of certain personal information relating to one (1) New Hampshire resident. This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, HCC does not waive any rights or defenses regarding the applicability of New Hampshire law, the applicability of the New Hampshire data event notification statute, or personal jurisdiction.

#### Nature of the Data Event

On August 3, 2022, HCC discovered unusual activity on certain computer systems. HCC disconnected these systems from the network and commenced an investigation to determine the nature and scope of the activity. Through the investigation, it was determined that certain files stored within the HCC environment were potentially accessed and/or acquired by an unauthorized actor. Thereafter, HCC began a comprehensive review of its files to determine the information potentially impacted and to whom the information related for purposes of notification. Upon completion of this review, HCC worked diligently to reconcile this information with its internal records to confirm the appropriate contact information for those individuals. HCC completed its reconciliation efforts on October 24, 2022, and thereafter worked to notify potentially impacted individuals as quickly as possible.

The information that could have been subject to unauthorized access includes name, Social Security number and driver's license or state identification information.

### Notice to New Hampshire Resident

On or about November 3, 2022, HCC provided written notice of this incident to one (1) New Hampshire resident. Written notice is being provided in substantially the same form as the letter attached here as **Exhibit A**.

## Other Steps Taken and To Be Taken

Upon discovering the event, HCC moved quickly to investigate and respond to the incident, assess the security of its systems, and identify potentially affected individuals. Further, HCC notified Federal law enforcement. HCC is also working to implement additional technical security measures designed to prevent a similar event in the future. HCC is providing access to credit monitoring services for one (1) year, through Equifax, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, HCC is providing impacted individuals with guidance on how to better protect against identity theft and fraud, information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud. HCC is also providing written notice of this incident to relevant state and federal regulators, as necessary.

Holmes Community College ("HCC") is writing to notify you of a recent event that may affect the security of some of your information. This notice provides you with information about the event, our response, and steps you may take to better protect your information, should you feel it is appropriate to do so.

What Happened? On August 3, 2022, HCC discovered unusual activity on certain computer systems. HCC immediately disconnected these systems from the network and commenced an investigation to determine the nature and scope of the activity. Through the investigation, it was determined that certain files stored within the HCC environment were potentially accessed and/or acquired by an unauthorized actor. Thereafter, HCC began a comprehensive review of its files to determine the information potentially impacted and to whom the information related for purposes of notification. Upon completion of this review, HCC worked diligently to reconcile this information with our internal records to confirm the appropriate contact information for those individuals. We completed our reconciliation efforts on October 24, 2022 and thereafter worked to notify potentially impacted individuals as quickly as possible.

What Information Was Involved? The information related to you that was potentially impacted includes your name, <<data elements>>.

What We Are Doing. HCC takes this incident and the security and privacy of information in our care very seriously. In response to the event, we took steps to secure our systems, and conducted a diligent investigation to confirm the full nature and scope of the event. Further, as part of our ongoing commitment to the privacy of information in our care, we implemented additional technical security measures designed to prevent a similar event in the future. We are also reviewing and enhancing our existing policies and procedures relating to data protection and security. We have notified federal law enforcement of this incident, as well as appropriate state and federal regulators.

As an added precaution we are offering you access to <<CM Length>>> of credit monitoring and identity theft protection services through Equifax at no cost to you. If you wish to activate these services, you may follow the instructions included in the attached Steps You Can Take To Help Protect Personal Information. We encourage you to enroll in these services as we are unable to do so on your behalf.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your accounts and monitoring your free credit reports for suspicious activity and to detect errors. We also encourage you to review the enclosed Steps You Can Take To Help Protect Personal Information section of this letter for additional information. You can also enroll to receive the complimentary monitoring services that we are offering to you.

You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be

aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

Full name (including middle initial as well as Jr., Sr., II, III, etc.);

Social Security number;

Date of birth;

Addresses for the prior two to five years;

Proof of current address, such as a current utility bill or telephone bill;

6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and

 A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
