Re: Incident Notification

Dear Attorney General Formella:

We are writing on behalf of our client, Kelly Insurance & Investments, Inc., to notify your office of a security incident. Kelly Insurance & Investments, Inc. is a financial advisory firm located in Annapolis, Maryland.

On March 1, 2023, Kelly Insurance & Investments, Inc. detected unauthorized access to certain devices in its network that resulted in the encryption of one of its systems. Upon identifying the unauthorized access, Kelly Insurance & Investments, Inc. took steps to secure its network and launched an investigation.

The investigation was not able to determine the period of unauthorized access but, on May 31, 2023, the investigation determined an unauthorized person accessed files and folders that contained personal information including

. Kelly Insurance & Investments, Inc. then worked to identify the individuals whose information was accessed as a result of the incident, including ten (10) New Hampshire residents.

On November 2, 2023, Kelly Insurance & Investments, Inc. began mailing notification letters to the New Hampshire residents via U.S. mail in accordance with N.H. Rev. Stat. Ann. § 359-C:20.¹ A copy of the notification letter is enclosed. Kelly Insurance & Investments, Inc. is providing a telephone number for notified individuals to call with any questions they may have about the incident. Kelly Insurance & Investments, Inc. is offering notified individuals a

complimentary membership to credit monitoring and identity protection services.


To help prevent this type of incident from happening again, Kelly Insurance & Investments, Inc. has implemented additional measures to enhance its existing security protocols.

What Happened?

On March 1, 2023, Kelly Insurance & Investments, Inc. ("Kelly Insurance") was alerted to a cybersecurity incident involving unauthorized access to one of our systems. Upon detection, we quickly took steps to secure our network and launch an investigation. On May 31, 2023, the investigation determined that certain files stored on the Kelly Insurance's system was taken by an unauthorized party.

What Information Was Involved?

We reviewed the files that were taken and determined that the stolen data may include your

ENROLLMENT INSTRUCTIONS

1. Website and Enrollment. Scan the QR image or go to <u>https://app.idx.us/account-creation/protect</u> and follow the instructions for enrollment using your Enrollment Code provided at the top of the letter. Please note the deadline to enroll is February 2, 2023.

2. Activate the credit monitoring provided as part of your IDX identity protection membership. The monitoring included in the membership must be activated to be effective. Note: You must have established credit and access to a computer and the internet to use this service. If you need assistance, IDX will be able to assist you.

3. Telephone. Contact IDX at 1-888-7433-805 to gain additional information about this event and speak with knowledgeable representatives about the appropriate steps to take to protect your credit identity.

If you discover any suspicious items and have enrolled in IDX identity protection, notify IDX immediately by calling or by logging into the IDX website and filing a request for help.

If you file a request for help or report suspicious activity, you will be contacted by a member of our ID Care team who will help you determine the cause of the suspicious items. In the unlikely event that you fall victim to identity theft as a consequence of this incident, you will be assigned an ID Care Specialist who will work on your behalf to identify, stop and reverse the damage quickly.

ADDITIONAL STEPS YOU CAN TAKE

We remind you it is always advisable to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity over the next 12 to 24 months. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. Fraud Alerts and Credit or Security Freezes:

Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. For information and instructions to place a security freeze, contact each of the credit reporting agencies at the addresses below:

You'll need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.
