
We serve as counsel for the Law Offices of Donald Mastrodomenico, P.C. ("Donald Mastrodomenico") located at 107-19 71 Avenue, Forest Hills, NY 11375 and provide this notification to your Office of a recent data security incident suffered by Donald Mastrodomenico. By providing this notice, Donald Mastrodomenico does not waive any rights or defenses under New Hampshire law, including the data breach notification statute.

On July 20, 2023, Donald Mastrodomenico became aware of potential unauthorized access to certain employee email accounts. Upon discovery, Donald Mastrodomenico immediately performed password resets for the affected accounts and swiftly engaged a third-party team of forensic investigators in order to determine the full nature and scope of the incident. Following a thorough investigation, Donald Mastrodomenico confirmed that a limited amount of information may have been accessed in connection with this incident.

On October 26, 2023, Donald Mastrodomenico discovered two (2) residents of New Hampshire whose may have been affected by this incident. As our investigation is ongoing, we will provide supplemental notification should we determine additional New Hampshire residents are potentially affected.

Donald Mastrodomenico provided written notice of this incident to the potentially impacted New Hampshire residents via First Class Mail on November 22, 2023, pursuant to New Hampshire state law. A copy of the notice letter is attached hereto as **Exhibit A**, which provides details of the incident, complimentary credit monitoring services for , and steps impacted individuals can take to protect their data.

We take the privacy and security of information in our care very seriously. While we have no evidence to suggest that any information was subject to actual or attempted misuse as a result of this incident, we wanted to provide notification regarding this incident so you can take steps to protect your information, should you feel it is appropriate to do so.

What Happened:

On July 20, 2023, Donald Mastrodomenico became aware of potential unauthorized access to certain employee email accounts. Upon discovery, we immediately performed password resets for the affected accounts and swiftly engaged a third-party team of forensic investigators in order to determine the full nature and scope of the incident. On October 26, 2023, following a thorough investigation, Donald Mastrodomenico confirmed that a limited amount of information may have been accessed in connection with this incident.

At this time, there is no indication that any information has been misused. However, we are providing this notification to you out of an abundance of caution and so that you may take steps to safeguard your information if you feel it is necessary to do so.

What Information Was Involved:

It is important to note, as mentioned above, that there is no evidence to suggest that any information has been misused. The information that <u>could have been accessed</u> by the unauthorized individual(s) may have included your

Donald Mastrodomenico has taken steps to address the incident and is committed to protecting personal information in its care. Upon learning of this incident, we immediately took steps to secure our email tenant and undertook a thorough investigation.

Credit Monitoring:

As an additional safeguard, we have arranged for you to enroll in, at no cost to you, an online credit monitoring service for <<<u>Credit Monitoring Length></u> provided by IDX. Due to privacy laws, we cannot activate these services for you directly. We encourage you to contact IDX with any questions and to enroll in free identity protection services by calling 1-888-859-9414 or going to https://app.idx.us/account-creation/protect and using the QR Code provided above. IDX representatives are available Monday through Friday from 9 am - 9 pm Eastern Time. Please note the deadline to enroll is February 22, 2024. Additional information regarding how to activate the complimentary monitoring service is enclosed.

What You Can Do:

In addition to enrolling in the complimentary credit monitoring service detailed within, we recommend that you remain vigilant in regularly reviewing and monitoring all of your account statements and credit history to guard against any unauthorized transactions or activity. If you discover any suspicious or unusual activity on any of your accounts, please promptly change your password and take additional steps to protect your account, and notify your financial institution or company if applicable. Additionally, please report any suspicious incidents to local law enforcement and/or your State Attorney General. You can also review the enclosed "Steps You Can Take to Help Protect Your Information" for additional resources.

STEPS YOU CAN TAKE TO HELP PROTECT YOUR INFORMATION

Activate Identity Monitoring Services

- **1. Website and Enrollment.** Scan the QR image or go to https://app.idx.us/account-creation/protect and follow the instructions for enrollment using your Enrollment Code provided at the top of the letter.
- **2. Activate the credit monitoring** provided as part of your IDX identity protection membership. The monitoring included in the membership must be activated to be effective. Note: You must have established credit and access to a computer and the internet to use this service. If you need assistance, IDX will be able to assist you.
- **3. Telephone.** Contact IDX at 1-888-859-9414 to gain additional information about this event and speak with knowledgeable representatives about the appropriate steps to take to protect your credit identity.

Monitor Your Accounts

We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your credit reports/account statements and explanation of benefits forms for suspicious activity and to detect errors. Under U.S. law, you are entitled to one free credit report annually from each of the three major credit reporting bureaus, TransUnion, Experian, and Equifax. To order your free credit report, visit www.annualcreditreport.com or call 1-877-322-8228. Once you receive your credit report, review it for discrepancies and identify any accounts you did not open or inquiries from creditors that you did not authorize. If you have questions or notice incorrect information, contact the credit reporting bureau.

You have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any of the three credit reporting bureaus listed below.

As an alternative to a fraud alert, you have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without your express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

- 1. Full name (including middle initial as well as Jr., Sr., III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Address for the prior two to five years;
- 5. Proof of current address, such as a current utility or telephone bill;
- 6. A legible photocopy of a government-issued identification card (e.g., state driver's license or identification card); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft, if you are a victim of identity theft.
