Dear Attorney General Formella:

We are writing on behalf of our client, LendUS, LLC ("LendUS"), to notify you of a security incident involving New Hampshire residents. LendUS is located in Alamo, California.

LendUS completed an investigation into unauthorized access to some LendUS employee email accounts. Upon first learning of the activity, LendUS immediately took steps to secure the email accounts and began an investigation with the assistance of a cybersecurity firm. The investigation determined that an unauthorized person accessed certain accounts at various times between February 2, 2021 and March 22, 2021. The investigation was not able to determine whether any emails or attachments in the accounts were accessed or downloaded by the unauthorized individual; however, LendUS was not able to rule out that possibility. Out of an abundance of caution, LendUS reviewed the emails and attachments that could have been accessed or downloaded. On December 21, 2021, LendUS determined that an email or attachment contained the names and one or more of the following belonging to two New Hampshire residents: Social Security numbers; financial account numbers; and/or payment card numbers.

On January 19, 2022, LendUS will begin mailing notification letters to the New Hampshire residents via First Class U.S. Mail pursuant to N.H. Rev. Stat. Ann. § 359-C:20. A sample copy of the notification letter is enclosed. LendUS is offering each of the New Hampshire residents whose Social Security number was found in the emails and attachments a complimentary, one-year membership to credit monitoring, fraud consultation, and identity theft restoration services through Equifax. LendUS is recommending that the individuals remain vigilant to the possibility of fraud or identity theft by reviewing their account statements for unauthorized activity. LendUS has also established a dedicated call center that individuals may call with related questions.

To further protect information in its systems, LendUS has implemented additional safeguards and technical security measures, including a universal password reset and multi-factor authentication, to further enhance the security of its computer systems and is providing additional email security awareness training to employees.

LendUS, LLC ("LendUS") understands the importance of protecting the personal information we maintain. I am writing to notify you of an incident that involved some of your personal information. This notice explains the incident, measures we have taken, and some steps you may consider taking in response.

We completed an investigation into unauthorized access to some LendUS employee email accounts. Upon first learning of the activity, we immediately took steps to secure the email accounts and began an investigation with the assistance of a cybersecurity firm. The investigation determined that an unauthorized person accessed certain accounts at various times between February 2, 2021 and March 22, 2021. The investigation was not able to determine whether any emails or attachments in the accounts were accessed or downloaded by the unauthorized individual; however, we were not able to rule out that possibility. Out of an abundance of caution, we reviewed the emails and attachments that could have been accessed or downloaded and, on December 21, 2021, determined that an email or attachment contained your <<Data Elements>>>.

We wanted to make you aware of this incident and assure you that we take it very seriously. We encourage you to remain vigilant by reviewing your account statements and credit reports for any unauthorized activity. If you see charges or activity you did not authorize, please contact the relevant financial institution or credit bureau immediately. As an added precaution, we are offering you a complimentary one-year membership with **Equifax CompleteTM Premier**, including credit monitoring and fraud alerts. Your confidence and trust are important to us, and we regret any inconvenience or concern this incident may cause. ADDITIONAL STEPS YOU CAN TAKE

We remind you it is always advisable to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity over the next twelve to twenty-four months. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. Obtain a copy of the police report in case you are asked to provide copies to creditors to correct your records. Contact information for the Federal Trade Commission is as follows:

If your health insurance or medical information was involved, it is also advisable to review the billing statements you receive from your health insurer or healthcare provider. If you see charges for services you did not receive, please contact the insurer or provider immediately.

If your username and password to an online account was involved, it is also advisable to change your password to the account as well as any other accounts that use the same or a similar password.

Fraud Alerts and Credit or Security Freezes:

Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. You'll need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.

Summary of Your Rights Under the Fair Credit Reporting Act: The federal Fair Credit Reporting Act (FCRA) promotes the accuracy, fairness, and privacy of information in the files of consumer reporting agencies. There are many types of consumer reporting agencies, including credit bureaus and specialty agencies (such as agencies that sell information about check writing histories, medical records, and rental history records). Your major rights under the FCRA are summarized below. - You must be told if information in your file has been used against you.
- You have the right to know what is in your file.
- You have the right to ask for a credit score.
- You have the right to dispute incomplete or inaccurate information.
- Consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information.
- Consumer reporting agencies may not report outdated negative information.
- Access to your file is limited.
- You must give your consent for reports to be provided to employers.
- You may limit "prescreened" offers of credit and insurance you get based on information in your credit report.
- You have a right to place a "security freeze" on your credit report, which will prohibit a consumer reporting agency from releasing information in your credit report without your express authorization.
- You may seek damages from violators.
- Identity theft victims and active duty military personnel have additional rights.
