RE: Data Breach Notification

To Whom It May Concern:

We serve as counsel for Livingston Street Capital, LLC ("LSC") located at 170 N Radnor Chester Rd #250, Radnor, PA 19087. We write to provide notification of a recent data breach. By providing this notice, LSC does not waive any rights or defenses under New Hampshire law, including the data breach notification statute.

On May 3, 2023, LSC discovered unusual activity in a company email account and immediately took counter measures in order to quickly limit any further unauthorized access. LSC also began an investigation with the assistance of third-party specialists, and the investigation determined there was unauthorized access to certain employee email accounts between May 2, 2023 and May 3, 2023. Therefore, LSC conducted an extensive review of the accounts to determine the information contained in the accounts and to whom it related.

On September 10, 2023, LSC completed its initial review and began locating address information to notify potentially affected individuals. The investigation determined the accounts included name, Social Security number, and banking/financial account information. LSC identified approximately five New Hampshire residents who may have been impacted by this incident.

In response to this incident, LSC changed account passwords and reviewed its policies and procedures. Additionally, LSC provided notice to the potentially impacted individuals on October 26, 2023, via U.S. mail. A copy of the notice is attached as *Exhibit A*. In an abundance of caution, LSC is offering the potentially impacted individuals complimentary credit monitoring and identity protection services.

STEPS YOU CAN TAKE TO PROTECT YOUR INFORMATION

Enroll in Credit Monitoring / Identity Protection

- 1. Website and Enrollment. Scan the QR image or go to https://app.idx.us/account-creation/protect and follow the instructions for enrollment using your Enrollment Code provided at the top of the letter. The enrollment deadline is January 26, 2024.
- 2. Telephone. Contact IDX at 1-800-939-4170 to gain additional information about this event and speak with knowledgeable representatives about the appropriate steps to take to protect your credit identity.
- 3. Activate the credit monitoring provided as part of your IDX identity protection membership. The <<12/24>>-month monitoring included in the membership must be activated to be effective. Note: You must have established credit and access to a computer and the internet to use this service. If you need assistance, IDX will be able to assist you.

If you discover any suspicious items and have enrolled in IDX identity protection, notify them immediately by calling or by logging into the IDX website and filing a request for help.

If you file a request for help or report suspicious activity, you will be contacted by a member of our ID Care team who will help you determine the cause of the suspicious items. In the unlikely event that you fall victim to identity theft as a consequence of this incident, you will be assigned an ID Care Specialist who will work on your behalf to identify, stop, and reverse the damage quickly.

Monitor Your Accounts

We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your credit reports/account statements for suspicious activity and to detect errors. Under U.S. law, you are entitled to one free credit report annually from each of the three major credit reporting bureaus, TransUnion, Experian, and Equifax. To order your free credit report, visit www.annualcreditreport.com or call 1-877-322-8228. Once you receive your credit report, review it for discrepancies and identify any accounts you did not open or inquiries from creditors that you did not authorize. If you have questions or notice incorrect information, contact the credit reporting bureau.

You have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any of the three credit reporting bureaus listed below.

As an alternative to a fraud alert, you have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without your express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

- 1. Full name (including middle initial as well as Jr., Sr., III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Address for the prior two to five years;
- 5. Proof of current address, such as a current utility or telephone bill;
- 6. A legible photocopy of a government-issued identification card (e.g., state driver's license or identification card); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft, if you are a victim of identity theft.
