Incident Notification

Dear Sir or Madam:

We are writing on behalf of our client, Los Angeles Philharmonic Association to notify you of a data security incident involving one New Hampshire resident on behalf of our client. Los Angeles Philharmonic Association is an orchestra out of Los Angeles, California.

Los Angeles Philharmonic Association recently completed an investigation into suspicious activity originating from one employee's email account on December 16, 2020. Upon learning of the incident, Los Angeles Philharmonic Association immediately took measures to secure the email accounts, contacted law enforcement, and launched an internal investigation. A cybersecurity firm was engaged to assist in a full forensic analysis of this incident. The investigation determined that an unauthorized person accessed the employee's email account at various times between December 3, 2020 and December 16, 2020.

The investigation was unable to determine, what messages, if any, were accessed. In an abundance of caution, Los Angeles Philharmonic Association reviewed the emails in the accounts to identify individuals whose information may have been accessible to the unauthorized person. On February 1, 2021, Los Angeles Philharmonic Association determined that information stored in the email accounts contained the name and Social Security number belonging to one resident of New Hampshire.

On March 4, 2021, in accordance with N.H. Rev. Stat. Ann. § 359-C:20, Los Angeles Philharmonic Association will mail a notification letter via First Class U.S. mail to the New

Hampshire resident. A sample copy of the notification letter is enclosed. To help monitor for any potential misuse of personal information, Los Angeles Philharmonic Association is offering a complimentary one-year membership in credit monitoring and identity theft protection services through Experian to the affected New Hampshire resident. Los Angeles Philharmonic Association has also established a dedicated phone number that individuals may call with related questions.

To reduce the risk of a similar incident occurring in the future, Los Angeles Philharmonic Association has taken additional steps to enhance the existing electronic security protocols and is re-educating staff for awareness on these types of incidents.

Notice of Data Breach

Dear << Name 1>>:

At the Los Angeles Philharmonic Association, we understand the importance of securing and protecting the personal information we maintain. I am writing to inform you of an incident that may have involved some of your personal information. This notice explains the incident, measures we have taken, and some steps you can take in response.

What Happened

We recently completed an investigation into suspicious activity originating from one employee's email account on December 16, 2020. As soon as we became aware of the suspicious activity, we immediately took measures to secure the email account, contacted law enforcement, and launched an internal investigation. A cybersecurity firm was engaged to assist in a full forensic analysis of this incident. The investigation determined that an unauthorized person accessed the employee's email account at various times between December 3, 2020 and December 16, 2020.

What Information was Involved

Our investigation was unable to determine what messages, if any, were accessed. Therefore, we performed a comprehensive review of the mailboxes, and on February 1, 2021, determined that information stored in the email accounts may have contained your name, address, date of birth, passport number, and Social Security number.

What You Can Do

Though we have no indication that your information has been misused, we are notifying you out of an abundance of caution and offering you a complimentary membership of Experian's Identity Works. What We are Doing

If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. Obtain a copy of the police report in case you are asked to provide copies to creditors to correct your records. Contact information for the Federal Trade Commission is as follows:

If your health insurance or medical information was involved, it is also advisable to review the billing statements you receive from your health insurer or healthcare provider. If you see charges for services you did not receive, please contact the insurer or provider immediately.

If your username and password to an online account was involved, it is also advisable to change your password to the account as well as any other accounts that use the same or a similar password.

Fraud Alerts and Credit or Security Freezes:

Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud-an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. You'll need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.
