Re: Supplemental Legal Notice of Information Security Incident

Dear Sir or Madam:

I am writing to follow up on the ransomware attack that targeted Magellan Health Inc. on behalf of Lucent Health Solutions, Inc. ("Lucent Health"), a third party administrator and a customer of Magellan Health Inc.'s affiliate Magellan Rx Management, LLC ("Magellan"). Magellan processes protected health information ("PHI") as a Business Associate of Lucent Health, which in turn is a Business Associate of its own clients.

Magellan was the target of a ransomware attack that exposed the personal information of 45 New Hampshire residents that are associated with Lucent Health's clients. The PHI included names and one or more of the following: treatment information, health insurance account information, member ID, other health-related information, email addresses, phone numbers, and physical addresses. Attached is a list of the Lucent Health customers that Lucent Health has authorized Magellan to submit to your office.

Magellan received authorization to provide notice to affected individuals and regulators on Lucent Health's behalf on December 11, 2020 and expects to provide direct notice to affected individuals by mail on or around December 17, 2020.
