Re: Incident Notification

Dear Assistant Attorney General Delaney:

On March 5, 2013, our client, Montana State University ("MSU"), discovered unusual activity on a computer in a central administration department. The computer was immediately taken offline and MSU began an investigation to examine what happened. MSU also hired an expert computer forensics company to assist with its investigation. After completing a thorough analysis of the computer, the forensics company determined that a computer virus may have allowed an unauthorized person to access information on the computer. Upon learning this, MSU diligently reviewed the files on the computer to determine the type of information involved. MSU identified employment information regarding current and former MSU employees, including names and Social Security numbers. No financial or bank account information was involved.

Even though MSU did not find any evidence to confirm that any unauthorized person accessed personal information, as a precautionary measure and in order to help those affected detect possible misuse of their information, MSU is providing eligible individuals with one year of complimentary credit monitoring services through Experian. MSU is also providing call center support for those affected.

MSU has taken steps to prevent a similar incident from occurring in the future, including a comprehensive review of its information security practices and procedures and re-education of its employees regarding online security awareness.

We are notifying 5 New Hampshire residents in substantially the same form as the letter attached hereto, with mailing commencing on June 13, 2013. As described above, MSU diligently investigated the incident and is notifying New Hampshire residents as soon as possible. See N.H. REV. STAT. § 359-C:20(I)(a).
