Re: Incident Notification

Dear Sir or Madam:

We are writing on behalf of our client, MountainOne, to notify you of a security incident.

MountainOne completed an investigation into suspicious activity by an unauthorized actor that was limited to the email accounts of two employees. Upon discovering this activity, MountainOne promptly secured both email accounts, commenced an investigation with the assistance of a forensic firm, and took measures to address the incident. The investigation determined that the email accounts were subject to unauthorized access at various times between July 29, 2022 and August 4, 2022 and between August 9, 2022 and August 10, 2022. The exhaustive investigation was unable to determine which emails or attachments the unauthorized actor may have accessed or viewed. Out of an abundance of caution, MountainOne reviewed the emails and attachments that could have potentially been accessed or viewed in the two email accounts and determined, on November 4, 2022, that an email or attachment contained information belonging to ten New Hampshire residents, including their names and one or more of the following: Social Security number, driver's license number or financial account number.

On December 9, 2022, MountainOne will mail notification letters to the New Hampshire residents in accordance with N.H. Rev. Stat. Ann. § 359-C:20, via United States First-Class mail. A copy of the notification letter is enclosed. MountainOne is offering the New Hampshire residents a complimentary one-year membership to credit monitoring and identity theft protection services. MountainOne also has established a dedicated, toll-free call center that individuals can call to obtain more information regarding the incident. To prevent something like this from happening again, MountainOne has taken steps to enhance its existing security measures.

We are writing to notify you of a business email compromise that potentially involves some of your personal information. This notice explains the incident, measures we have taken and some steps you may consider taking in response.

We recently concluded an investigation into suspicious activity by an unauthorized actor that was limited to the email accounts of two employees. **None of our internal banking infrastructure or data management systems were involved in this incident.** Upon discovering this activity, we promptly secured both email accounts, commenced an investigation with the assistance of a forensic firm, and took measures to address the incident. The investigation determined that two employee email accounts were subject to unauthorized access at various times between July 29, 2022 and August 4, 2022 and August 9-10, 2022. The exhaustive investigation was unable to determine which emails or attachments the unauthorized actor may have accessed or viewed. Out of an abundance of caution, we reviewed the emails and attachments that could have potentially been accessed or viewed in the two email accounts and determined, on November 4, 2022, that an email or attachment contained your name and <<Data Elements>>.

MountainOne is committed to protecting the information that we maintain. We assure you that we take this incident very seriously. As a protective precaution for you, we secured the services of Equifax Credit Watch® Gold. This product provides you with identity detection and resolution of identity theft should it happen to you. Equifax Credit Watch® Gold is completely free to you and enrolling in this program will not hurt your credit score. For more information on Equifax Credit Watch® Gold, including instructions on how to activate your complimentary one-year membership, as well as some additional steps you can take in response, please see the pages that follow this letter.

While our thorough investigation did not uncover any actual fraud on your accounts, we'd like to remind you to remain vigilant to the possibility of fraud by reviewing your account statement and credit reports for any unauthorized activity on a regular basis. You should immediately report any unauthorized activity to all your financial institutions.

We sincerely regret any inconvenience or concern this incident may cause. To help prevent a similar incident in the future, we have implemented additional security measures and controls. ADDITIONAL STEPS YOU CAN TAKE

We remind you it is always advisable to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity over the next 12-24 months. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. To order your annual free credit report, please visit www.annualcreditreport.com or call toll free at 1-877-322-8228. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. Fraud Alerts and Credit or Security Freezes:

Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. You'll need to supply your name, address, date of birth, Social Security number and other personal information. After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.
