Re: Notice of Data Event

Dear Sir or Madam:

We represent Qumpus Inc. d/b/a Better World Books ("BWB") located at 55740 Currant Road, Mishawaka, IN 46545, and are writing to notify your office of an incident that may affect the security of some personal information relating to one (1) New Hampshire resident. This notice may be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, BWB does not waive any rights or defenses regarding the applicability of New Hampshire law, the applicability of the New Hampshire data event notification statute, or personal jurisdiction.

Nature of the Data Event

On October 4, 2021, BWB identified suspicious activity related to certain servers. BWB quickly worked to secure their system and launched an investigation to determine the nature and scope of the activity. Through the investigation, BWB determined that an unknown actor gained access to certain systems between September 22, 2021 and October 4, 2021 and downloaded certain files from those systems. BWB then worked to perform a comprehensive review of those files to determine what information was impacted and to whom the information related. Upon completion of the review, BWB conducted a manual review of their records to determine the identities and contact information for potentially affected individuals. Recently, BWB confirmed address information for affected individuals to provide notifications.

The information that could have been subject to unauthorized access includes name, address, and Social Security number.

Notice to New Hampshire Residents

On or about April 19, 2022, BWB provided written notice of this incident to all affected individuals, which includes one (1) New Hampshire resident. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, BWB moved quickly to investigate and respond to the incident, assess the security of BWB systems, and notify potentially affected individuals. BWB is also working to implement additional safeguards and training to its employees. BWB is providing access to credit monitoring services for 24 months, through Experian to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, BWB is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. BWB is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Dear Sample A. Sample:

Qumpus, Inc. d/b/a Better World Books ("BWB") is writing to inform you of an event that may impact the security of some of your information. While we have received no indication of actual misuse of your information as a result of this event, this notice provides information about the event, our response, and resources available to you to help protect your information from possible misuse, should you feel it appropriate to do so.

What Happened? On October 4, 2021, BWB identified suspicious activity related to certain servers. We quickly worked to secure our system and launched an investigation to determine the nature and scope of the activity. Through our investigation, we determined that an unknown actor gained access to certain systems between September 22, 2021 and October 4, 2021 and downloaded certain files from those systems. We then worked to perform a comprehensive review of those files to determine what information was impacted and to whom the information related. Upon completion of the review, we conducted a manual review of our records to determine the identities and contact information for potentially affected individuals. Recently, we confirmed address information for affected individuals to provide notifications.

What Information Was Involved. Our investigation determined that the impacted information may have included your name, address, and Social Security number.

What We Are Doing. The confidentiality, privacy, and security of information in our care are among our highest priorities, and we take this incident very seriously. We are reviewing our security policies and procedures to reduce the risk of similar future events. Although we do not have any indication of identity theft or fraud as a result of this event, we are offering complimentary credit monitoring and identity restoration services through Experian for 24 months as an added precaution. We also reported this event to federal law enforcement and notified appropriate state regulators.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud and to review your account statements and free credit reports for suspicious activity and to detect errors. Additional information and resources are included in the enclosed *Steps You Can Take to Protect Personal Information*. You may also enroll in the complementary credit monitoring services available to you. Enrollment instructions are enclosed with this letter.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
