Incident Notification

Dear Attorney General MacDonald:

We are writing on behalf of our client, Rosa Mexicano Company, to notify you of a security incident involving New Hampshire residents. Rosa Mexicano is restaurant providing contemporary Mexican cuisine. Rosa Mexicano's headquarters are located in New York, New York.

Rosa Mexicano recently concluded an investigation of an incident that involved unauthorized access to employees' email accounts. Upon first suspecting unauthorized access, Rosa Mexicano immediately secured the accounts and launched an investigation with assistance from a computer forensics firm.

In connection with that investigation, Rosa Mexicano learned that an unauthorized party gained access to the employees' email accounts between October 6, 2020 and November 4, 2020. The investigation was unable to determine whether the unauthorized party actually viewed any emails or attachments in the accounts. In an abundance of caution, Rosa Mexicano reviewed the emails and attachments contained in the email accounts to identify individuals whose information may have been accessible to the unauthorized party. On February 19, 2021, Rosa Mexicano determined that an email and/or attachment contained the name and one or more of the following data elements of 15 New Hampshire residents: Social Security number, driver's license number, financial account number, and/or payment card number.

Beginning on March 25, 2021, Rosa Mexicano is providing written notice via United States Postal Service mail to the New Hampshire residents whose information was potentially accessed by an

unauthorized party. A sample copy of the letter is enclosed. Rosa Mexicano is offering a complimentary one-year membership in credit monitoring and identity theft protection services through Experian to the New Hampshire residents whose Social Security number or driver's license number was involved. The notice letter also provides a dedicated telephone number that notice recipients can call with any questions they may have.

To help prevent a similar incident from occurring in the future, Rosa Mexicano is implementing additional policies and security features to enhance its security posture and increasing employee cybersecurity training.

Rosa Mexicano understands the importance of protecting the information we maintain. We are writing to inform you about a data security incident that may have involved some of your information. This notice explains the incident, measures we have taken, and some steps you may consider taking.

Rosa Mexicano recently concluded an investigation of an incident that involved unauthorized access to employees' email accounts. Upon first suspecting unauthorized access, we immediately secured the accounts and launched an investigation with assistance from a computer forensics firm.

In connection with that investigation, we learned that an unauthorized party gained access to the employees' email accounts at various times between October 6, 2020 and November 4, 2020. Our investigation was unable to determine whether the unauthorized party actually viewed any emails or attachments in the accounts. In an abundance of caution, we reviewed the emails and attachments contained in the email accounts to identify individuals whose information may have been accessible to the unauthorized party. On February 19, 2021, we determined that the accounts included an email and/or attachment containing your <<br/>betatoric [Impacted Data]>>>

To date, we are unaware of any misuse of any of the information in the employees' email accounts, nor do we have any evidence that any emails or attachments containing your information were actually viewed. However, we wanted to inform you of this event, assure you that we take this very seriously, and provide you with ways to protect your information. As a precaution, we have secured the services of Experian® to offer you a complimentary one-year membership in Experian's Identity Works<sup>SM</sup>. This product helps detect possible misuse of your information and provides you with identity protection support focused on immediate identification and resolution of identity theft. Identity Works is completely free and enrolling in this program will not hurt your credit score. For more information on Identity Works, including instructions on how to activate your complimentary one-year membership, as well as some additional steps you can take to protect your information, please see the pages that follow this letter. We encourage you to remain vigilant by reviewing your financial account statements for any unauthorized activity. If you see charges or activity you did not authorize, please contact your financial institution immediately.

We regret any concern this incident may cause you. To help prevent something like this from happening in the future, we are implementing additional policies and security features to enhance our security posture and increasing employee cybersecurity training. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. You'll need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.
