Dear Sir/Madam:

We write on behalf of our client Ryder System, Inc. ("Ryder") to notify you that Ryder identified an unauthorized intrusion on certain of its systems by a third party on or about December 17, 2020. Ryder took immediate action to investigate and secure its systems. After conducting a comprehensive review of this incident, Ryder determined that some data files were taken from its systems. Ryder subsequently performed an assessment of these data files and recently determined that some personal information was accessed.

After taking immediate action to investigate and secure its systems, Ryder retained a leading forensic firm to conduct a review of the incident to determine the nature and scope of the unauthorized access. Ryder notified appropriate law enforcement and also implemented additional security measures to help further protect against this type of incident going forward. After conducting a comprehensive analysis of the compromised data to determine the affected individuals, Ryder determined that the incident potentially affected 24 New Hampshire residents. The personal information at issue for New Hampshire residents includes name and social security number.

Ryder is taking action to provide assistance to potentially affected individuals, even though it currently has no evidence of any misuse of or fraudulent activity relating to anyone's personal information as a result of this incident. Ryder has notified affected individuals by mail on or about June 8, 2021 and will provide 24 months of identity theft monitoring services from Experian. Ryder has also provided information about steps that individuals can take to protect themselves, such as regularly monitoring financial statements and credit reports. A template copy of the notification letter Ryder has sent to affected New Hampshire residents is attached to this notice as Appendix A.

Notice of Data Breach

Dear Sample A. Sample:

We write to notify you of an incident that occurred that could affect some of your personal information. Please review this letter carefully.

What Happened

Ryder System, Inc. ("Ryder") identified an unauthorized intrusion of certain of our systems by a third party on or about December 17, 2020. We took immediate action to investigate and secure our systems. After conducting a comprehensive review of this incident, we determined that some data files were taken from our systems. We subsequently performed an assessment of these data files and recently determined that some of your personal information was accessed.

What Information Was Involved

The personal information affected included some or all of the following items pertaining to you: your name, address, social security number, date of birth and/or driver's license number. At this time, we are not aware of any misuse of or fraudulent activity relating to anyone's personal information as a result of this incident.

What We Are Doing

We are sending you this notice as a precaution and to encourage you to take steps to monitor your personal information. Ryder undertook a review to determine the nature and scope of the incident. After the review, we implemented additional security measures to help further protect against this type of incident going forward.

Although we are not aware of any misuse of or fraudulent activity relating to anyone's personal information as a result of this incident, as an added precaution we are offering complimentary access to Experian IdentityWorksSM for 24 months, at no cost to you.



To start monitoring your personal information, please follow the steps below:

- Ensure that you enroll by September 30, 2021 (Your code will not work after this date.)

ATTACHMENT B

ADDITIONAL STEPS TO HELP PROTECT YOUR INFORMATION

Monitor Your Accounts

We recommend that you regularly review statements from your accounts and periodically obtain your credit report from one or more of the national credit reporting companies. You may obtain a free copy of your credit report online at www.annualcreditreport.com, by calling toll-free 1-877-322-8228, or by mailing an Annual Credit Report Request Form (available at www.annualcreditreport.com) to Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA, 30348-5281. You may also purchase a copy of your credit report by contacting one or more of the three national credit reporting agencies listed below.

When you receive your credit reports, review them carefully. Look for accounts or creditor inquiries that you did not initiate or do not recognize. Look for information, such as home address and Social Security number that is not accurate. If you see anything you do not understand, call the credit reporting agency at the telephone number on the report.

Credit Freeze

You have the right to put a security freeze, also known as a credit freeze, on your credit file, so that no new credit can be opened in your name without the use of a Personal Identification Number (PIN) that is issued to you when you initiate a freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to access your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. Should you wish to place a credit freeze, please contact all three major consumer reporting agencies listed below.

You must separately place a credit freeze on your credit file at each credit reporting agency. The following information should be included when requesting a credit freeze:

- 1) Full name, with middle initial and any suffixes;
- 2) Social Security number;
- 3) Date of birth (month, day, and year);
- 4) Current address and previous addresses for the past five (5) years:
- 5) Proof of current address, such as a current utility bill or telephone bill;
- 6) Other personal information as required by the applicable credit reporting agency;

If you request a credit freeze online or by phone, then the credit reporting agencies have one (1) business day after receiving your request to place a credit freeze on your credit file report. If you request a lift of the credit freeze online or by phone, then the credit reporting agency must lift the freeze within one (1) hour. If you request a credit freeze or lift of a credit freeze by mail, then the credit agency must place or lift the credit freeze no later than three (3) business days after getting your request.

Fraud Alerts

You also have the right to place an initial or extended fraud alert on your file at no cost. An initial fraud alert lasts 1year and is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting 7 years. Should you wish to place a fraud alert, please contact any one of the agencies listed below. The agency you contact will then contact the other two credit agencies.
