Re: Notice of Data Event

To Whom It May Concern:

We represent the Sierra Club, located at 2101 Webster St., Suite 1300, Oakland, CA 94612, and are writing to notify your office of an incident that may affect the security of certain personal information relating to two (2) New Hampshire residents. This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, the Sierra Club does not waive any rights or defenses regarding the applicability of New Hampshire law, the applicability of the New Hampshire data event notification statute, or personal jurisdiction.

## Nature of the Data Event

Sierra Club recently concluded its investigation into an incident involving a former employee's misuse of an electronic file containing personal information for certain Sierra Club employees. The investigation determined that on February 3, 2023, a Sierra Club employee forwarded and/or blind-copied a file containing a limited amount of personal information for certain Sierra Club employees to their personal email account. The employee transferred this file while they were employed by Sierra Club. The individual responsible for this event is no longer employed by the Sierra Club.

Upon learning of the activity, Sierra Club immediately began an investigation and took steps to further mitigate the risk to this information. That review determined that the files that were transferred to a personal account without authorization contained individuals'

# **Notice to New Hampshire Residents**

On October 4, 2023, Sierra Club provided written notice of this incident to two (2) New Hampshire residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

# Other Steps Taken and To Be Taken

Upon discovering the event, Sierra Club moved quickly to investigate and respond to the incident, review the files that were sent to an unauthorized account, and identify potentially affected individuals. The individual responsible for this incident is no longer employed by the Sierra Club. The Sierra Club is providing access to credit monitoring services for through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Sierra Club is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. Sierra Club is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Sierra Club is providing written notice of this incident to relevant state regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion.

The Sierra Club writes to notify you of an event that may affect the privacy of some of your personal information. Although we have no evidence of misuse of your information, we write to provide you with information about the event, our response, and steps you can take to help protect against the possible misuse of your information, should you feel it is appropriate to do so.

## What Happened?

Sierra Club recently concluded its investigation involving a former employee's interaction with an electronic file containing personal information for certain Sierra Club employees. The investigation determined that on or about February 3, 2023, a Sierra Club employee forwarded and/or blind-copied a file containing a limited amount of information for certain Sierra Club employees to their personal email account. The employee transferred this file while they were employed by Sierra Club and had access to this information as part of their employment duties at that time. The activity was discovered by Sierra Club during a security audit. Upon learning of the activity, we immediately began an investigation and took steps to further mitigate the risk to this information. The individual responsible for this event is no longer employed by the Sierra Club.

#### What Information Was Involved?

We are notifying you because our investigation determined that your information was present in the file that emailed by the former employee to their personal email address. This information includes your

#### What We Are Doing.

Sierra Club is committed to maintaining the confidentiality of its information, protecting the privacy rights of its employees, and ensuring that its proprietary information remains in its sole possession. After learning of the former employee's actions, we promptly launched an investigation to determine the scope of information involved. We also took steps to mitigate the risk to the impacted file in accordance with our internal policies and procedures. The individual responsible for this event is no longer employed with Sierra Club. We are also notifying relevant regulatory authorities, as required.

Although we have no evidence that your information was used for identity theft or fraud, as an added precaution, we are offering you access to credit monitoring and identity theft protection services for through Experian at no cost to you. If you wish to activate these complimentary services, you may follow the instructions included in the attached *Steps You Can Take to Protect Personal Information*. We encourage you to enroll in these services as we are unable to act on your behalf to do so.

#### What You Can Do.

We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors over the nex . Although we are unaware of any misuse of your information, we have arranged for Experian to provide complimentary credit monitoring and identity protection services for you for as an added precaution. Please review the enrollment instructions contained in the enclosed "Steps You Can Take to Protect Personal Information" to enroll. Although these services are being offered to you free of cost, you will need to enroll in these services yourself.

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit <a href="https://www.annualcreditreport.com">www.annualcreditreport.com</a> or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer's name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit.

Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

## **Additional Information**

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General.
