Re: Notice of Data Event

To Whom It May Concern:

We represent Soroc Technology Inc. ("Soroc") located at 607 Chislea Road, Woodbridge, Ontario, Canada L4L8A3, and are writing to notify your office of an incident that may affect the personal information of four (4) New Hampshire residents. By providing this notice, Soroc does not waive any rights or defenses regarding the applicability of New Hampshire law, the applicability of the New Hampshire data event notification statute, or personal jurisdiction.

Nature of the Data Event

On May 15, 2023, Soroc discovered a ransomware incident on its internal IT systems. The breach occurred at various times between approximately May 12 to May 14, 2023. Soroc learned of the breach upon contact by the malicious actor making demands for payment. Soroc promptly took steps to secure its systems and commenced an investigation into the nature and scope of the event. Soroc has been working diligently to investigate this incident.

Notice to New Hampshire Residents

On or about June 20, 2023, Soroc provided written notice of this incident to four (4) New Hampshire residents. Written notice is being provided in substantially the same form as the letter attached here as **Exhibit A**.

Steps Taken and To Be Taken

Upon discovering the event, Soroc quickly took steps to secure their systems and mitigate the impact to data. Leading cybersecurity experts were immediately engaged to assist Soroc in dealing with the incident, including closing any outside access, investigating any unauthorized access, and strengthening their overall cybersecurity. Law enforcement was also notified of the event. Soroc is providing affected individuals access to identity theft and credit monitoring services from TransUnion for

Additionally, Soroc is providing affected individuals with guidance on how to report identity theft to the Federal Trade Commission and obtain recovery steps in the event their personal information is misused.
