Re: Notice of Data Event

Dear Sir or Madam:

We represent Spiraledge, Inc., 1919 S. Bascom Ave, Ste 300, Campbell, CA ("Spiraledge"), and are writing to notify your office of an incident affecting Spiraledge's e-commerce sites, www.SwimOutlet.com and www.YogaOutlet.com that may affect the security of personal information relating to certain New Hampshire residents. By providing this notice, Spiraledge does not waive any rights or defenses regarding the applicability of New Hampshire law, the applicability of the New Hampshire data event notification statute, or personal jurisdiction.

Nature of the Data Event

On October 31, 2016, Spiraledge began investigating some unusual activity reported by its credit card processor. Spiraledge immediately began to work with third-party forensic experts to investigate these reports and to identify any signs of compromise on its systems. On November 28, 2016, Spiraledge discovered that it was the victim of a sophisticated cyber-attack that resulted in the potential compromise of some customers' debit and credit card data used at www.swimoutlet.com and www.yogaoutlet.com between May 2, 2016 to November 22, 2016.

Since that time, Spiraledge has been working with third-party forensic investigators to determine what happened, what information was affected and to implement additional procedures to further protect the security of customer debit and credit cards. Spiraledge removed the malware at issue to prevent any further

unauthorized access to customer debit or credit card information. Spiraledge is also working with the Federal Bureau of Investigations to investigate this incident. Customers can safely use your payment card at www.swimoutlet.com and www.yogaoutlet.com.

Notice to New Hampshire Residents

Through the ongoing third-party forensic investigations, Spiraledge confirmed on November 28, 2016 that malware may have stolen credit or debit card data from some credit and debit cards used at www.swimoutlet.com and www.yogaoutlet.com between May 2, 2016 and November 22, 2016. The information at risk as a result of this event includes the cardholder's name, address, phone number, email address, card number, expiration date and CVV. Spiraledge determined that personally identifiable information relating to 2,421 New Hampshire residents may have been compromised. Spiraledge is providing written notice of this incident to these potentially impacted New Hampshire residents who made purchases on swimoutlet.com during the May 2, 2016 to November 22, 2016 window beginning on or about January 12, 2017, in substantially the same form as the letter attached hereto as **Exhibit A**. Spiraledge is providing written notice of this incident to these potentially impacted New Hampshire residents who made purchases on YogaOutlet.com during the May 2, 2016 to November 22, 2016 window beginning on or about January 12, 2017, in substantially the same form as the letter attached hereto as **Exhibit B**.

Other Steps Taken and To Be Taken

Spiraledge is working with the FBI to investigate this incident. Spiraledge has established a dedicated hotline for individuals to contact with questions or concerns regarding this incident. Additionally, Spiraledge is providing potentially impacted individuals with helpful information on how to protect against identity theft and fraud, including how to place a fraud alert and security freeze on one's credit file, the contact information for the national consumer reporting agencies, how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, state attorney general, and law enforcement to report attempted or actual identity theft and fraud. Spiraledge is also providing written notice of this incident to other state regulators and the national consumer reporting agencies as necessary.



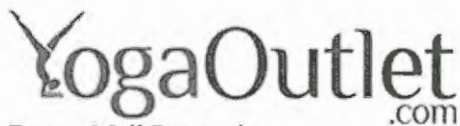


