Re: Incident Notification

Dear Attorney General Formella:

We are writing on behalf of our client, TBK Bank, SSB ("TBK"), to notify your office of a security incident involving New Hampshire residents.

TBK identified a cybersecurity incident involving unauthorized access to an employee's email account. Upon discovery of the incident, TBK immediately launched an investigation and took steps to secure the email account. A cybersecurity firm was engaged, and the investigation determined that an unauthorized party was able to access the employee's email account between December 1-6, 2021.

The investigation was unable to determine which emails and attachments the unauthorized individual may have accessed. Out of an abundance of caution, TBK conducted a review of the emails and attachments in the employee email account to identify any personal customer information that may have been accessed. The unauthorized access to the email account was terminated on December 6, 2021. On January 28, 2022, TBK identified nine New Hampshire residents' whose personal information may have been accessed. The data that may have been involved included the residents names and one or more of the following: Social Security number, financial account number, passport number, or driver's license or state-issued identification number.

On March 16, 2022, TBK is notifying nine New Hampshire residents via U.S. mail in

accordance with N.H. Rev. Stat. Ann. § 359-C:20.<sup>1</sup> A copy of the notification letter is enclosed. TBK is providing a telephone number for potentially affected individuals to call with any questions they may have about the incident and is providing complimentary credit monitoring to individuals whose Social Security numbers or driver's license numbers may have been involved.

To help prevent something like this from happening again, TBK has implemented additional measures to enhance already existing security protocols.

We are writing to inform you of an incident that may have involved some of your personal information. This notice explains the incident, measures we have taken, and additional steps you may consider taking in response.

We identified a cybersecurity incident involving unauthorized access to a TBK Bank employee's email account. Upon discovery of the incident, we immediately launched an investigation and took steps to secure the email account. A cybersecurity firm was engaged, and the investigation determined that an unauthorized party was able to access the employee's email account between December 1-6, 2021. The unauthorized access to the email account was terminated on December 6, 2021.

The investigation could not rule out the possibility that the unauthorized person viewed emails or attachments in the employee's account before we terminated access. Out of an abundance of caution, we conducted a review of the emails and attachments in the employee email account to identify any personal customer information that may have been accessed. We completed that review on January 28, 2022 and determined that an email or attachment contained your name and one or more of the following: Social Security number, driver's license or State-issued identification number, and/or Passport number.

We encourage you to remain vigilant by reviewing your account statements and credit reports for any unauthorized activity. If you notice any unauthorized activity, you should notify the relevant financial institution or credit bureau reporting the unauthorized activity immediately.

As a precaution, we are offering you a free one-year membership in Experian's® IdentityWorks<sup>SM</sup> Credit 3B. This service provides you with identity detection and resolution of identity theft. IdentityWorks Credit 3B is completely free to you and enrolling in this program will not hurt your credit score. For more information on IdentityWorks Credit 3B, including instructions on how to activate your complimentary one-year membership, as well as some additional steps you can take in response, please see the pages that follow this letter.

If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. ### Fraud Alerts and Credit or Security Freezes:

Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

*Credit or Security Freezes:* You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. For information and instructions to place a security freeze, contact each of the credit reporting agencies at the addresses below:

You'll need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.

West Virginia: You have the right to ask that nationwide consumer reporting agencies place "fraud alerts" in your file to let potential creditors and others know that you may be a victim of identity theft, as described above. You also have a right to place a security freeze on your credit report, as described above.

A Summary of Your Rights Under the Fair Credit Reporting Act: The federal Fair Credit Reporting Act (FCRA) promotes the accuracy, fairness, and privacy of information in the files of consumer reporting agencies. There are many types of consumer reporting agencies, including credit bureaus and specialty agencies (such as agencies that sell information about check writing histories, medical records, and rental history records). Your major rights under the FCRA are summarized below. - You must be told if information in your file has been used against you.
- You have the right to know what is in your file.
- You have the right to ask for a credit score.
- You have the right to dispute incomplete or inaccurate information.
- Consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information.
- Consumer reporting agencies may not report outdated negative information.
- Access to your file is limited.
- You must give your consent for reports to be provided to employers.
- You may limit "prescreened" offers of credit and insurance you get based on information in your credit report.
- You have a right to place a "security freeze" on your credit report, which will prohibit a consumer reporting agency from releasing information in your credit report without your express authorization.
- You may seek damages from violators.
- Identity theft victims and active duty military personnel have additional rights.
