Subject: Home Health & Hospice Care and Solution Health finalize plans to affiliate and Develop Innovative Post-Acute Care Services.

We are pleased to share with you that today (8/10/2021) we have officially filed a Definitive Agreement, between Home Health & Hospice Care and SolutionHealth, with the State of New Hampshire Attorney General Charitable Trusts Unit. This agreement

defines our plans to affiliate with SolutionHealth in order to provide enhanced post-acute care services to the people of southern New Hampshire.

The affiliation agreement allows for HHC to participate as a member of Solution Health, along with Southern New Hampshire Health, the Elliot and the Manchester VNA, and develop a fully integrated, system of post-acute care. The many benefits of this affiliation include: Seamless information sharing through the EPIC medical record system, expanded access to care, greater clinical specialty sophistication, operational efficiencies, improved patient and family experience and new and innovative programs to provide care in the home.

The regulatory review may take up to 180 days, during which time the Attorney General will solicit feedback and hold a public listening session. Assuming approval by state and federal officials, we will jointly develop integration teams focusing on clinical synergies, IT infrastructure (including the transition to the EPIC EMR), Human Resources (aligning benefits, etc.) and Finance.
