We can assure that Mascoma Community Health Center will offer accountable, affordable and sustainable health, mental, and dental care for decades.

Why become an FQHC?

- The Health Center, operated by HealthFirst, will qualify for a 40% increase in federal funding that ensures long term financial strength
- Federal low-cost pharmacy benefits
- An increase in available services and providers, including shared providers
- Access to behavioral health and medically-assisted drug treatment
- Dietary and health education

How will we become an FQHC?

Collaborating with HealthFirst Family Care Center out of Franklin, New Hampshire gives the Center rapid FQHC status.

Who is HealthFirst?

HealthFirst is a non-profit FQHC with health centers in Laconia and Franklin, New Hampshire that has operated for 27 years and is accountable to a patient-majority Board.

What happens to Mascoma Community Health Center?

MCHC stays right here. HealthFirst will manage and operate the health center day-to-day using our providers and staff. Mascoma Community Healthcare, Inc. will remain a nonprofit and owner of the Health Center, and will lease the facility to HealthFirst. Our mission will still be to serve as a patient advocate, help people take advantage of the advantage of the affordable services, and seek funding for new and expanded services at the health center.
