REQUEST FOR PRE-REGISTRATION REVIEW

Nonprofit organizations that do not operate in New Hampshire are not required to register here. In addition, not all nonprofits organizations are charitable. That includes most trade associations, fraternal groups and/or unions. If a nonprofit organization does not primarily have a charitable purpose, does not hold restricted trust funds and does not solicit publicly for charitable donations, then it is not required to register and file annual reports with the Attorney General. If you believe your organization may not be subject to the statutory registration and reporting requirements for charities, you may file this application for pre-registration review.

The law does not require you to submit a request, and the determination made may not be binding. However, note that failure of a charitable trust as defined in RSA 7:21, II, to register with the Charitable Trusts Unit may result in the imposition of civil penalties of up to \$10,000.
