Re: Notice of Data Event

Dear Mr. Foster:

We represent Angliss & Colohan, P.C., 21 New Britain Avenue, Suite 106, Rocky Hill, CT 06067, and are writing to notify your office of an incident that may affect the security of personal information relating to certain New Hampshire residents. By providing this notice, Angliss & Colohan, P.C. does not waive any rights or defenses regarding the applicability of New Hampshire law, the applicability of the New Hampshire data event notification statute, or personal jurisdiction.

**Nature of the Data Event**

On March 6, 2017, Angliss & Colohan, P.C. discovered that it had become the target of a phishing email campaign and that an employee had clicked on the phishing email and entered their credentials. Angliss & Colohan, P.C. immediately took steps to secure the employee's email account and launched an investigation, with the assistance of a third-party forensic investigator, to determine whether any sensitive information was accessed or acquired. On March 17, 2017, it determined, with the help of outside computer forensic investigators, that an unknown actor had gained access to the Angliss & Colohan, P.C. employee's email account. Angliss & Colohan, P.C. determined, after a lengthy programmatic and manual review of the contents of the email account, the types of protected information contained in the email account and to which clients the information relates on April 12, 2017, and immediately launched a review of its files to ascertain address information for its impacted clients. On May 11, 2017, Angliss & Colohan, P.C. completed its review of its files and located addresses for its impacted clients.

While there is no evidence that the individual(s) accessed or acquired personal information from the employee's email account, access to the information contained therein could not be ruled out.

the email account may have contained the name, date of birth, address, Social Security Number, and financial account information, of the affected New Hampshire residents.

### **Notice to New Hampshire Residents**

On May 30, 2017, Angliss & Colohan, P.C. will begin providing written notice of this incident to all affected individuals, which includes approximately ten (10) New Hampshire residents. Written notice will be provided in substantially the same form as the letter attached here as *Exhibit A*.

### **Other Steps Taken and To Be Taken**

Angliss & Colohan, P.C. is providing all potentially affected individuals access to 2 free years of credit and identity monitoring services, including identity restoration services, through Equifax, and has established a dedicated hotline for potentially affected individuals to contact with questions or concerns regarding this incident. Additionally, Angliss & Colohan, P.C. is providing potentially impacted individuals with guidance on how to better protect against identity theft and fraud, including information on how to place a fraud alert and security freeze on one's credit file, information on protecting against tax fraud, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud. Angliss & Colohan, P.C. is also providing written notice of this incident to other state regulators as necessary.

**Re: Notice of Data Breach**

Dear <Name 1>:

I am writing to inform you of a recent event that may affect the security of your personal information. You are receiving this letter because Angliss & Colohan, P.C. performed tax and accounting services for Frog Bridge Development Company LLC. While we are unaware of any actual or attempted misuse of your personal information, out of an abundance of caution, we are providing you with information about the incident. We are also providing you with information regarding the steps we are taking in response, and steps you can take to protect against fraud should you feel it is appropriate.

**What Happened?** On March 6, 2017, we discovered that Angliss & Colohan, P.C. had become the target of a phishing email campaign and that an employee had clicked on the phishing email and entered their credentials. We immediately took steps to secure this employee's email account and launched an in-depth investigation to determine whether any sensitive information was accessed or acquired.

Angliss & Colohan, P.C.'s email system is completely segregated from its server and the software it uses to store client tax return information. The security of the server and the software was not compromised during this event, as access to both the server and the software is restricted by unique credentials, and the employee's email account credentials cannot be used to access either the server or the software.

On March 17, 2017, we determined, with the help of outside computer forensic investigators, that an unknown actor had gained access to the Angliss & Colohan, P.C. employee's email account. Angliss & Colohan, P.C. determined, after a lengthy programmatic and manual review of the contents of the email account, the types of protected information contained in the email account and to which clients the information relates on April 12, 2017, and immediately launched a review of its files to ascertain address information for its impacted clients.

The information that was accessible was predominantly data emailed to Angliss & Colohan, P.C. by clients of Angliss & Colohan, P.C. While we currently have no evidence that anyone accessed or acquired this information, access to the information in the email account cannot be ruled out.

**What Information Was Involved?** While we currently have no evidence that the unauthorized individual or individuals actually accessed or acquired your information, we have confirmed that your name and <<data elements affected>> were accessible to the unknown actor during this event.

**What We Are Doing.** We take the security of information in our care very seriously. Since discovering this event, we have been working diligently with third-party forensic investigators to determine what happened and what information was accessible to the unknown actor. This has involved a time consuming, programmatic and manual data review process. We are providing notice of this event to you, and to certain regulators and consumer reporting agencies as required.

In addition to providing this notice to you, and even though we are unaware of any actual or attempted misuse of your information, as an added precaution, we have partnered with Equifax® to provide its ID Patrol identity theft protection product for two years at no charge to you. A description of this product is provided in the attached material, which also contains instructions about how to enroll (including your personal activation code).

If you choose to take advantage of this product, it will provide you with a notification of any changes to your credit information, up to \$1 million Identity Fraud Expense Coverage and access to your credit report.

Even if you decide not to take advantage of the subscription offer, you may still receive Equifax Identity Restoration in the event that you become victim of identity theft by calling 877-368-4940, 9:00a.m. to 8:00p.m. Eastern, Monday through Friday, before June 1, 2019.

You must complete the enrollment process for the Equifax ID Patrol product by September 10, 2017. We urge you to consider enrolling in this product, at our expense, and reviewing the Additional Resources enclosed with this letter.

**What You Can Do.** You can enroll to receive the complimentary monitoring and restoration services we are offering to you. You can also review the enclosed Privacy Safeguards Information for additional information on how to better protect against identity theft and fraud.

**For More Information.** We are very sorry for any inconvenience or concern this incident causes you. The security of your information is a priority for us. ## PRIVACY SAFEGUARDS INFORMATION

We encourage you to remain vigilant against incidents of identity theft and fraud, to review your account statements, and to monitor your credit reports and explanation of benefits forms for suspicious activity. Under U.S. law you are entitled to one free credit report annually from each of the three major credit reporting bureaus. You may also contact the three major credit bureaus directly to request a free copy of your credit report.

At no charge, you can also have these credit bureaus place a "fraud alert" on your file that alerts creditors to take additional steps to verify your identity prior to granting credit in your name. Note, however, that because it tells creditors to follow certain procedures to protect you, it may also delay your ability to obtain credit while the agency verifies your identity. As soon as one credit bureau confirms your fraud alert, the others are notified to place fraud alerts on your file. You may also place a security freeze on your credit reports. A security freeze prohibits a credit bureau from releasing any information from a consumer's credit report without the consumer's written authorization. However, please be advised that placing a security freeze on your credit report may delay, interfere with, or prevent the timely approval of any requests you make for new loans, credit mortgages, employment, housing, or other services. If you have been a victim of identity theft, and you provide the credit bureau with a valid police report, it cannot charge you to place, lift or remove a security freeze. In all other cases, a credit bureau may charge you a fee to place, temporarily lift, or permanently remove a security freeze. You will need to place a security freeze separately with each of the three major credit bureaus listed above if you wish to place a freeze on all of your credit files.
