 - On about May 20th, 2021, Aspiration systems were brute-forced attacked using email and password combinations surfaced from a deepweb site. On May 21st, our engineering and InfoSec teams were alerted of the brute-force attack. We identified approximately 14,000 aspiration customers that were affected (41 N.H. residents). Aspiration locked down access to accounts including the disabling of money movements. Aspiration rotated account numbers of those affected, including the issuance of new debit cards. Aspiration required affected customers to update their mobile app which included new MFA and security features. Aspiration notified affected customers on about June 7th, 2021.
