***Re: Legal Notice of Security Incident***

Dear Sir or Madam:

I am writing on behalf of my client, Atlas Technical Consultants ("Atlas"), to inform you that Atlas was the target of a security incident that involved the personal information of approximately 8 New Hampshire residents.

On July 29, 2023, Atlas discovered suspicious activity on certain internal systems. Atlas immediately launched an investigation and third party cybersecurity experts were engaged to assist in responding to and conducting a thorough investigation of the incident. Atlas also reported the incident to law enforcement and has been supporting law enforcement's investigation.

Atlas' investigation revealed that an unauthorized third party gained access to Atlas' environment and obtained certain files on or around July 28, 2023. Atlas undertook a time-intensive and robust review of the files to understand the contents of the data and identify individuals whose personal information may have been contained in the files. Atlas recently completed the review and determined that some of the files contained personal information related to current or former Atlas employees and dependents, including

Today, Atlas is notifying affected residents by First Class Mail and is offering of complimentary credit monitoring and identity theft protection services. A sample copy of the notification letter is attached. Atlas is also providing a toll-free hotline for individuals to call with any questions regarding the incident.

To help prevent a similar occurrence in the future, Atlas implemented numerous measures designed to enhance the security of its systems and data. If you have any questions or need additional information regarding this incident, please do not hesitate to contact me.

**Re: Notice of Security Incident**

Dear Sample A. Sample:

Atlas takes the security of personal information seriously. Regrettably, we are writing to inform you of a cybersecurity incident that may have involved some of your personal information. Although we have no indication of identity theft or fraud in relation to this event, this letter is to provide you with information of what happened, the measures we have taken in response, and proactive steps you may consider to help protect your information, should you feel it appropriate to do so.

**What Happened?**

On July 29, 2023, Atlas discovered suspicious activity on certain internal systems. Atlas immediately began an investigation and third party cybersecurity experts were engaged. The investigation found that an unauthorized actor accessed certain Atlas systems and, on or around July 28, 2023, obtained certain files. Atlas undertook a time-intensive and robust review of the files to understand the contents of the data and identify individuals whose personal information may have been contained in the files.

**What Information Was Involved?**

We recently completed our review of the files involved and determined that some of your personal information was contained in the files, including ]

**What We Are Doing.**

Upon learning of this incident, we moved quickly to investigate and respond to this incident with the assistance of third party cybersecurity experts. We also promptly notified law enforcement and are continuing to support law enforcement's investigation. Additionally, we implemented numerous measures designed to enhance the security of our systems and data to reduce the likelihood of a similar occurrence in the future.

While we have no evidence to suggest that your information was targeted or misused for purposes of fraud or identity theft, we wanted to provide you with information about the incident and protective measures you can take. As an additional precaution, we are offering you a complimentary membership of Experian IdentityWorks<sup>SM</sup>. This product helps detect possible misuse of your personal information and provides you with identity protection support focused on immediate identification and resolution of identity theft. IdentityWorks<sup>SM</sup> is completely free to you and enrolling in this program will not hurt your credit score.

We encourage you to review the additional information on IdentityWorks<sup>SM</sup>, including instructions on how to activate your complimentary membership, as well as information on additional steps you can take in response to this incident, on the pages that follow this letter.

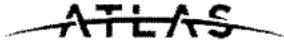

## ADDITIONAL STEPS YOU CAN TAKE

**Free Credit Report.** Regardless of whether you choose to take advantage of the complimentary identity monitoring, it is always advisable to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity. If you identify any unauthorized charges on your financial account statements, you should immediately report any such charges to your financial institution. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. **Security Freeze.** Security freezes, also known as credit freezes, restrict access to your credit file, making it harder for identity thieves to open new accounts in your name. You can freeze and unfreeze your credit file for free. You also can get a free freeze for your children who are under 16. And if you are someone's guardian, conservator or have a valid power of attorney, you can get a free freeze for that person, too.

How will these freezes work? Contact all three of the nationwide credit reporting agencies – Equifax, Experian, and TransUnion. If you request a freeze online or by phone, the agency must place the freeze within one business day. If you request a lift of the freeze, the agency must lift it within one hour. If you make your request by mail, the agency must place or lift the freeze within three business days after it gets your request. You also can lift the freeze temporarily without a fee.

Don't confuse freezes with locks. They work in a similar way, but locks may have monthly fees. If you want a free freeze guaranteed by federal law, then opt for a freeze, not a lock.

The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. You may obtain information from the credit reporting agencies and the FTC about security freezes.

**For New Mexico residents:** You may obtain a security freeze on your credit report to protect your privacy and ensure that credit is not granted in your name without your knowledge. You may submit a declaration of removal to remove information placed in your credit report as a result of being a victim of identity theft. You have a right to place a security freeze on your credit report or submit a declaration of removal pursuant to the Fair Credit Reporting and Identity Security Act. **Fraud Alerts.** A fraud alert tells businesses that check your credit that they should check with you before opening a new account. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years. To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report. You may obtain additional information from the credit reporting agencies and the FTC about fraud alerts.

**Federal Trade Commission and State Attorneys General Offices.** If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your home state. You may also contact these agencies for information on how to prevent or avoid identity
