Re: Incident Notification

Dear Attorney General MacDonald:

We are writing on behalf of our client, AtriCure, Inc (“AtriCure”), to notify you of a security incident involving New Hampshire residents. AtriCure is a medical device company headquartered in Mason, OH.

AtriCure conducted an investigation involving unauthorized access to employees’ email accounts. Upon first learning of the potential access, AtriCure immediately took measures to secure the email accounts and launched an investigation with the assistance of a professional security firm to determine the nature and scope of the incident. Through the investigation, AtriCure determined that an unauthorized party accessed the email accounts at various times between December 24, 2020 and March 8, 2021, but was unable to determine whether any emails or attachments in the accounts were actually viewed during that time. AtriCure performed a review of the emails and attachments that could have been viewed by the unauthorized party and, on April 7, 2021, determined that certain emails and attachments in the email accounts contained personal information, including the name and Social Security number of New Hampshire residents. After further investigation, AtriCure also determined that the emails and attachment that could have been viewed by the unauthorized party contained a limited amount of health information related to an AtriCure employee welfare plan. At the conclusion of its investigation, AtriCure identified seven New Hampshire residents whose information may have been involved in the incident.¹

Beginning today, June 4, 2021, AtriCure is providing written notice to the New Hampshire residents via First Class U.S. Mail.² A sample copy of the notification letter is enclosed. AtriCure is offering the New Hampshire residents a complimentary one-year membership in credit monitoring and identity theft protection services through Experian. AtriCure has also established a dedicated call center where all individuals may obtain more information regarding the incident.

To further protect personal information, AtriCure is taking steps to enhance its existing security protocols, including implementation of multi-factor authentication for email accounts, and re-educating its staff for awareness of these types of incidents.

At AtriCure, Inc., we take seriously our commitment to data security. I am writing to inform you of an incident that may have involved some of your information. This notice explains the incident, measures we have taken, and some steps you may consider taking.

We have conducted an investigation involving unauthorized access to several employees' email accounts. Upon learning of the unauthorized access, we immediately took steps to secure the accounts and began an investigation with the assistance of a professional forensic firm. The investigation determined that the accounts were accessed by an unauthorized person at various times between December 24, 2020, and March 8, 2021, but was unable to determine whether the unauthorized person viewed any emails or attachments in the accounts. In an abundance of caution, we reviewed the contents of the involved email accounts to identify specific individuals whose information may have been accessible. We conducted the review and analyzed the results between April 7, 2021, and May 6, 2021, and determined that an email or attachment included your <<Variable Text>>.

While we have no indication that your information has been misused, we wanted to assure you that we take this incident very seriously. As an added precaution, we are also offering you a complimentary one-year membership with Experian's® IdentityWorksSM. This product helps detect possible misuse of your personal information and provides you with identity protection support. **For more information on IdentityWorksSM, including instructions on how to activate your complimentary one-year membership, as well as some additional steps you can take, please see the additional information provided in this letter.** We encourage you to remain vigilant by reviewing your account statements and credit reports for any unauthorized activity. If you see charges or activity you did not authorize, please contact your financial institution immediately. We also recommend that you review any statements that you receive relating to your health insurance. If you identify any charges for services that you did not receive, please reach out to us immediately.

Your confidence and trust are important to us and we regret any inconvenience or concern this incident may cause. To help further protect against an incident like this, we are taking steps to enhance our existing security protocols and re-educating our staff for awareness on these types of incidents. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. If your health insurance or medical information was involved, it is also advisable to review the billing statements you receive from your health insurer or healthcare provider. If you see charges for services you did not receive, please contact the insurer or provider immediately.

Fraud Alerts and Credit or Security Freezes:

Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. For information and instructions to place a security freeze, contact each of the credit reporting agencies at the addresses below:

You'll need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.
