Re: Notice of Data Event

Dear Sir or Madam:

We represent The Beaver Excavating Company (“Beaver Excavating”) located at 2000 Beaver Place Ave SW, Canton, OH 44706, and are writing to notify your office of an incident that may affect the security of some personal information relating to one (1) New Hampshire resident. The investigation into this matter is ongoing, and this notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Beaver Excavating does not waive any rights or defenses regarding the applicability of New Hampshire law, the applicability of the New Hampshire data event notification statute, or personal jurisdiction.

Nature of the Data Event

On July 23, 2021, Beaver Excavating became aware of suspicious activity on its computer network. Beaver Excavating immediately secured its network and launched an investigation with the assistance of third-party computer specialists to determine the nature and scope of the incident. On August 4, 2021, the investigation determined that certain files on Beaver Excavating’s systems were potentially subject to unauthorized access between July 19, 2021 and July 23, 2021. Beaver Excavating then undertook a diligent and comprehensive review of the contents of these files in order to determine whether they contained sensitive information. On November 9, 2021, the review was completed, and Beaver Excavating confirmed that certain files containing personal information were in the impacted files that may have been accessed. The information that could have been subject to unauthorized access includes name, Social Security number, and driver's license number.

Notice to New Hampshire Resident

On or about December 29, 2021, Beaver Excavating provided written notice of this incident to all affected individuals, which includes one (1) New Hampshire resident. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, Beaver Excavating moved quickly to investigate and respond to the incident, assess the security of Beaver Excavating systems, and notify potentially affected individuals. Beaver Excavating is also working to implement additional safeguards and training to its employees. Beaver Excavating is providing access to credit monitoring services for one (1) year, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Beaver Excavating is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. Beaver Excavating is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Dear Sample A. Sample:

The Beaver Excavating Company (“Beaver Excavating”) writes to notify you of a recent incident that may impact the privacy of some of your information. We are providing you with information about the incident, our response to it, and resources available to you to help protect your information, should you feel it appropriate to do so.

What Happened? On July 23, 2021, Beaver Excavating became aware of suspicious activity on our computer network. We immediately secured our network and launched an investigation with the assistance of third-party computer specialists to determine the nature and scope of the incident. On August 4, 2021, the investigation determined that certain files on Beaver Excavating’s systems were potentially subject to unauthorized access between July 19, 2021 and July 23, 2021. We then undertook a diligent and comprehensive review of the contents of these files in order to determine whether they contained sensitive information. On November 9, 2021, the review was completed, and Beaver Excavating confirmed that certain files containing your information were in the impacted files, so your information could have been accessed.

What Information Was Involved? The potentially impacted information could include your name, [Extra2]. At this time, we have no indication that your information was subject to actual or attempted misuse as a result of this incident.

What We Are Doing. Beaver Excavating takes this incident and security of your information seriously. Upon discovering this incident, we immediately took steps to review and reinforce the security of our computing environment. We are reviewing our security policies, procedures, and processes, and additional workforce training is being conducted to reduce the likelihood of a similar future incident. We will notify applicable regulatory authorities, as required by law.

As an added precaution, we are also offering [Extra3] months of complimentary access to credit monitoring services through Experian IdentityWorks. Individuals who wish to receive these services must enroll by following the enrollment instructions found in the enclosed *Steps You Can Take to Help Protect Personal Information*.

Enroll in Credit Monitoring

To activate your membership and start monitoring your personal information please follow the steps below:

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
