Re: Boston College High School – Incident Notification

Dear Attorney General MacDonald:

McDonald Hopkins PLC represents Boston College High School. I am writing to provide notification of an incident at Boston College High School that may affect the security of personal information of approximately one (1) New Hampshire resident. Boston College High School's investigation is ongoing, and this notification will be supplemented with any new or significant facts or findings subsequent to this submission, if any. By providing this notice, Boston College High School does not waive any rights or defenses regarding the applicability of New Hampshire law or personal jurisdiction.

Boston College High School learned that multiple Boston College High School employee email accounts may have been compromised by an email phishing attack resulting in unauthorized access to the email boxes. Upon learning of the issue, Boston College High School immediately contained the issue and commenced a prompt and thorough investigation. As part of its investigation, Boston College High School has been working very closely with external data privacy and cybersecurity professionals experienced in handling these types of incidents. After an extensive forensic investigation and manual email review, Boston College High School discovered on December 12, 2019 that the impacted email accounts were accessed between August 3, 2019 to October 24, 2019 and contained some personal information, including the affected resident's full name and Social Security number.

To date, Boston College High School has no evidence that any of the information has been misused. Nevertheless, out of an abundance of caution, Boston College High School wanted to inform you (and the affected resident) of the incident and to explain the steps that it is taking to help safeguard the affected resident against identity fraud. Boston College High School will provide the affected resident with written notification of this incident commencing on or about February 18, 2020 in substantially the same form as the letter attached hereto. Boston College High School will offer the affected resident a complimentary one-year membership with

a credit monitoring service. Boston College High School will advise the affected resident about the process for placing fraud alerts and/or security freezes on his/her credit files and obtaining free credit reports. The affected resident will also be provided with the contact information for the consumer reporting agencies and the Federal Trade Commission.

At Boston College High School, protecting the privacy of personal information is a top priority. Boston College High School is committed to maintaining the privacy of personal information in its possession and has taken many precautions to safeguard it. Boston College High School continually evaluates and modifies its practices and internal controls to enhance the security and privacy of your personal information.

We are writing with important information regarding a recent email security incident. The privacy and security of the information provided to us is of the utmost importance to Boston College High School. As such, we wanted to provide you with information about the incident, explain the services we are making available to you, and let you know that we continue to take significant measures to safeguard your information.

What Happened?

We have learned that multiple Boston College High School employee email accounts may have been compromised by an email phishing attack resulting in unauthorized access to the email boxes.

What We Are Doing.

Upon learning of the issue, we immediately contained the issue and commenced a prompt and thorough investigation. As part of our investigation, we have been working very closely with external data privacy and cybersecurity professionals experienced in handling these types of incidents. After an extensive forensic investigation and manual email review, we discovered on December 12, 2019 that the impacted email accounts were accessed between August 3, 2019 to October 24, 2019 and contained some of your personal information. We have no evidence that any of the information has been misused. Nevertheless, out of an abundance of caution, we want to make you aware of the incident.

What Information Was Involved?

The impacted email accounts that were accessed contained some of your personal information, including your [REDACTED]

What You Can Do.

To protect you from potential misuse of your information, we are offering a complimentary one-year membership of Experian IdentityWorksSM Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on immediate identification and resolution of identity theft. IdentityWorks Credit 3B is completely free to you and enrolling in this program will not hurt your credit score. For more information on identity theft prevention and IdentityWorks Credit 3B, including instructions on how to activate your complimentary one-year membership, please see the additional information provided in this letter.

This letter also provides other precautionary measures you can take to help protect your personal information, including placing a fraud alert and/or security freeze on your credit files, and/or obtaining a free credit report. Additionally, you should always remain vigilant in reviewing your account statements for fraudulent or irregular activity on a regular basis.

2. Placing a Fraud Alert on Your Credit File.

Whether or not you choose to use the complimentary 12-month credit monitoring services, we recommend that you place an initial 1-year "fraud alert" on your credit files, at no charge. A fraud alert tells creditors to contact you personally before they open any new accounts. To place a fraud alert, call any one of the three major credit bureaus at the numbers listed below. As soon as one credit bureau confirms your fraud alert, they will notify the others.

3. Placing a Security Freeze on Your Credit File.

If you are very concerned about becoming a victim of fraud or identity theft, you may request a "security freeze" be placed on your credit file, at no charge. A security freeze prohibits, with certain specific exceptions, the consumer reporting agencies from releasing your credit report or any information from it without your express authorization. You may place a security freeze on your credit report by sending a request in writing or by mail, to all three nationwide credit reporting companies. In order to place the security freeze, you'll need to supply your name, address, date of birth, Social Security number and other personal information. After receiving your freeze request, each credit monitoring company will send you a confirmation letter containing a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

4. Obtaining a Free Credit Report.

Under federal law, you are entitled to one free credit report every 12 months from each of the above three major nationwide credit reporting companies. Call **1-877-322-8228** or request your free credit reports online at **www.annualcreditreport.com**. Once you receive your credit reports, review them for discrepancies. Identify any accounts you did not open or inquiries from creditors that you did not authorize. Verify all information is correct. If you have questions or notice incorrect information, contact the credit reporting company.

5. Accessing Additional Helpful Resources.

Even if you do not find any suspicious activity on your initial credit reports, the Federal Trade Commission (FTC) recommends that you check your credit reports periodically. Checking your credit report periodically can help you spot problems and address them quickly.

If you find suspicious activity on your credit reports or have reason to believe your information is being misused, call your local law enforcement agency and file a police report. Be sure to obtain a copy of the police report, as many creditors will want the information it contains to absolve you of the fraudulent debts. You may also file a complaint with the FTC by contacting them on the web at www.ftc.gov/idtheft, by phone at 1-877-IDTHEFT (1-877-438-4338), or by mail at Federal Trade Commission, Consumer Response Center, 600 Pennsylvania Avenue, NW, Washington, DC 20580. Your complaint will be added to the FTC's Identity Theft Data Clearinghouse, where it will be accessible to law enforcement for their investigations. In addition, you may obtain information from the FTC about fraud alerts and security freezes.
