Re: BPG Real Estate Services – Incident Notification

Dear Mr. Formella:

McDonald Hopkins PLC represents BPG Real Estate Services (“BPG”). I am writing to provide notification of an incident that may affect the security of personal information of one (1) New Hampshire resident. BPG’s investigation is ongoing, and this notification will be supplemented with any new or significant facts or findings subsequent to this submission, if any. By providing this notice, BPG does not waive any rights or defenses regarding the applicability of New Hampshire law or personal jurisdiction.

On September 2, 2021, BPG detected potential unauthorized access to its network. Upon learning of this issue, BPG contained and secured the threat, commenced a prompt and thorough investigation, and notified law enforcement. BPG immediately launched an investigation in consultation with outside cybersecurity professionals to help determine whether any sensitive data had been compromised because of the incident. BPG’s investigation determined that the unauthorized individual(s) potentially removed certain files and folders from portions of its network between August 29, 2021 and September 2, 2021. On October 14, 2021, following an extensive review and analysis of the data at issue, BPG determined that certain files and folders potentially removed from its network contained the resident’s full name and Social Security number.

At the time of this notification, BPG is not aware of any reports of identity theft or fraud arising out of this incident. Nevertheless, out of an abundance of caution, BPG wanted to inform you (and the affected resident) of the incident and to explain the steps that it is taking to help safeguard the affected resident against identity fraud. BPG is providing the affected resident with written notification of this incident commencing on or about November 5, 2021 in substantially the same form as the letter attached hereto. If a Social Security number was impacted, BPG is offering the affected resident complimentary one-year membership with a credit monitoring service. BPG will advise the affected resident to always remain vigilant in reviewing financial account statements for fraudulent or irregular activity on a regular basis. BPG will advise the affected resident about the process for placing a fraud alert and/or security freeze on their credit

files and obtaining free credit reports. The affected resident is also being provided with the contact information for the consumer reporting agencies and the Federal Trade Commission.

At BPG, protecting the privacy of personal information is a top priority. BPG is committed to maintaining the privacy of personal information in its possession and has taken many precautions to safeguard it. BPG continually evaluates and modifies its practices to enhance the security and privacy of the personal information it maintains.

We are writing with important information regarding a recent security incident. The privacy and security of the personal information we maintain is of the utmost importance to The Buccini/Pollin Group ("BPG"). We wanted to provide you with information about the incident, explain the services we are making available to you, and let you know that we continue to take significant measures to protect your personal information.

What Happened?

On September 2, 2021, BPG detected potential unauthorized access to its network.

What We Are Doing

Upon learning of this issue, we contained and secured the threat, commenced a prompt and thorough investigation, and notified law enforcement. We immediately launched an investigation in consultation with outside cybersecurity professionals who regularly investigate and analyze these types of situations to help determine whether any sensitive data had been compromised because of the incident. Our investigation determined that the unauthorized party potentially removed certain files and folders from portions of our network between August 29, 2021 and September 2, 2021.

What Information Was Involved

On October 14, 2021, following an extensive review and analysis of the data at issue, we determined that certain files and folders potentially removed from our network contained your [REDACTED]. Given the unauthorized network access, potential acquisition of certain files and the value we place on our relationship with you, we wanted to notify you about this incident.

What You Can Do

To date, we are not aware of any reports of identity theft or fraud arising out of this incident. Nevertheless, out of an abundance of caution, we want to make you aware of the incident. To protect you from potential misuse of your information, we are offering a complimentary one-year membership in Equifax® Credit Watch™ Gold. Equifax® Credit Watch™ Gold is completely free to you and enrolling in this program will not hurt your credit score. For more information on identity theft prevention and Equifax® Credit Watch™ Gold, including instructions on how to activate your complimentary one-year membership, please see the additional information provided in this letter.

This letter also provides other precautionary measures you can take to protect your personal information, including placing a Fraud Alert and Security Freeze on your credit files, and obtaining a free credit report. Additionally, you should always remain vigilant in reviewing your financial account statements and credit reports for fraudulent or irregular activity on a regular basis.

2. Placing a Fraud Alert on Your Credit File.

3. Consider Placing a Security Freeze on Your Credit File.

If you are very concerned about becoming a victim of fraud or identity theft, you may request a "Security Freeze" be placed on your credit file, at no charge. A security freeze prohibits, with certain specific exceptions, the consumer reporting agencies from releasing your credit report or any information from it without your express authorization. You may place a security freeze on your credit report by contacting all three nationwide credit reporting companies at the numbers below and following the stated directions or by sending a request in writing, by mail, to all three credit reporting companies:

In order to place the security freeze, you'll need to supply your name, address, date of birth, Social Security number and other personal information. After receiving your freeze request, each credit reporting company will send you a confirmation letter containing a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

If your personal information has been used to file a false tax return, to open an account or to attempt to open an account in your name or to commit fraud or other crimes against you, you may file a police report in the City in which you currently reside.

If you do place a security freeze *prior* to enrolling in the credit monitoring service as described above, you will need to remove the freeze in order to sign up for the credit monitoring service. After you sign up for the credit monitoring service, you may refreeze your credit file.

4. Obtaining a Free Credit Report.

Under federal law, you are entitled to one free credit report every 12 months from each of the above three major nationwide credit reporting companies. Call 1-877-322-8228 or request your free credit reports online at www.annualcreditreport.com. Once you receive your credit reports, review them for discrepancies. Identify any accounts you did not open or inquiries from creditors that you did not authorize. Verify all information is correct. If you have questions or notice incorrect information, contact the credit reporting company.

5. Additional Helpful Resources.

Even if you do not find any suspicious activity on your initial credit reports, the Federal Trade Commission (FTC) recommends that you check your credit reports periodically. Checking your credit report periodically can help you spot problems and address them quickly.

If you find suspicious activity on your credit reports or have reason to believe your information is being misused, call your local law enforcement agency and file a police report. Be sure to obtain a copy of the police report, as many creditors will want the information it contains to absolve you of the fraudulent debts. You may also file a complaint with the FTC by contacting them on the web at www.ftc.gov/idtheft, by phone at 1-877-IDTHEFT (1-877-438-4338), or by mail at Federal Trade Commission, Consumer Response Center, 600 Pennsylvania Avenue, NW, Washington, DC 20580. Your complaint will be added to the FTC's Identity Theft Data Clearinghouse, where it will be accessible to law enforcement for their investigations. In addition, you may obtain information from the FTC about fraud alerts and security freezes.

If this notice letter states that your financial account information and/or credit or debit card information was impacted, we recommend that you contact your financial institution to inquire about steps to take to protect your account, including whether you should close your account or obtain a new account number.
