Re: Notice of Data Security Incident

Dear Attorney General Formella:

Constangy, Brooks, Smith & Prophete LLP (“Constangy”) represents Buckley King LPA (“Buckley King”) in connection with a data security incident described in greater detail below.

1. Nature of the security incident.

On April 11, 2023, Buckley King discovered that it had experienced an incident disrupting access to certain of its systems. In response, Buckley King took immediate steps to secure its systems and promptly launched an investigation. In so doing, Buckley King engaged independent digital forensics and incident response experts to determine what happened and to identify any information that may have been accessed or acquired without authorization. On November 17, 2023, Buckley King determined that certain personal information may have been impacted and then took steps to effectuate notification to potentially impacted individuals as quickly as possible. Please note that Buckley King has no evidence of the misuse or attempted misuse of any potentially impacted information.

The information that may have been accessible by the malicious actor responsible for this incident includes potentially impacted individuals’

2. Number of New Hampshire residents affected.

On December 26, 2023, Buckley King will be notifying 40 New Hampshire residents of this incident via first class U.S. mail. A sample copy of the notification letter is included with this correspondence.

3. Steps taken relating to the Incident.

As soon as Buckley King discovered this incident, Buckley King launched an investigation to determine what happened and to identify the scope of potentially impacted information. In addition, Buckley King implemented measures to enhance the security of its digital environment in an effort to minimize the risk of a similar incident occurring in the future. Buckley King also notified the

Federal Bureau of Investigation of this incident and will provide whatever cooperation is necessary to hold the perpetrator(s) of the incident accountable.

Buckley King has established a toll-free call center through IDX, a leader in risk mitigation and response, to answer any questions about the incident and address related concerns. The call center is available at 1-888-796-4579 from 8:00 A.M. to 8:00 P.M. Central Time, Monday through Friday (excluding holidays). In addition, out of an abundance of caution, Buckley King is also providing complimentary credit monitoring and identity protection services to notified individuals.

I am writing to inform you of a recent data security incident experienced by Buckley King LPA (“Buckley King”) that may have affected your personal information. Buckley King takes the privacy and security of all personal information within its possession very seriously. Please read this letter carefully as it contains information regarding the incident and steps that you can take to help protect your personal information.

What Happened? On April 11, 2023, Buckley King discovered that it had experienced an incident disrupting access to certain of its systems. In response, Buckley King took immediate steps to secure its systems and promptly launched an investigation. In so doing, Buckley King engaged independent digital forensics and incident response experts to determine what happened and to identify any information that may have been accessed or acquired without authorization. On November 17, 2023, Buckley King learned that your personal information may have been impacted in connection with the incident which is the reason for this notification. Please note that Buckley King has no evidence of the misuse or attempted misuse of any potentially impacted information.

What Information Was Involved? The information potentially impacted in connection with this incident included

What Are We Doing? As soon as Buckley King discovered this incident, Buckley King took the steps described above. In addition, Buckley King implemented measures to enhance the security of its digital environment in an effort to minimize the risk of a similar incident occurring in the future. Buckley King also notified the Federal Bureau of Investigation of this incident and will provide whatever cooperation is necessary to hold the perpetrator(s) of the incident accountable.

Although Buckley King has no evidence of the misuse of any potentially impacted information, Buckley King is providing you with information about steps that you can take to help protect your personal information and is offering you complimentary identity protection services through IDX – a data breach and recovery services expert. These services include <<12/24>> months of credit¹ and dark web monitoring, a \$1 million identity fraud loss reimbursement policy, and fully managed identity theft recovery services.

The deadline to enroll in these services is March 26, 2024. With this protection, IDX will help to resolve issues if your identity is compromised.

¹To receive credit monitoring services, you must be over the age of 18 and have established credit in the U.S., have a Social Security number in your name, and have a U.S. residential address associated with your credit file.

What You Can Do: You can follow the recommendations on the following page to help protect your personal information. Buckley King also encourages you to enroll in the complementary services being offered to you through IDX by using the enrollment code provided above.

STEPS YOU CAN TAKE TO HELP PROTECT YOUR INFORMATION

Review Your Account Statements and Notify Law Enforcement of Suspicious Activity: As a precautionary measure, we recommend that you remain vigilant by reviewing your account statements and credit reports closely. If you detect any suspicious activity on an account, you should promptly notify the financial institution or company with which the account is maintained. You also should promptly report any fraudulent activity or any suspected incidence of identity theft to proper law enforcement authorities, your state attorney general, and/or the Federal Trade Commission (FTC).

Fraud Alert: You may want to consider placing a fraud alert on your credit report. An initial fraud alert is free and will stay on your credit file for at least one year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any accounts in your name. To place a fraud alert on your credit report, contact any of the three credit reporting agencies identified above. Additional information is available at <http://www.annualcreditreport.com>.

Security Freeze: You have the right to put a security freeze on your credit file for up to one year at no cost. This will prevent new credit from being opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A security freeze is designed to prevent potential creditors from accessing your credit report without your consent. As a result, using a security freeze may interfere with or delay your ability to obtain credit. You must separately place a security freeze on your credit file with each credit reporting agency. In order to place a security freeze, you may be required to provide the consumer reporting agency with information that identifies you including your full name, Social Security number, date of birth, current and previous addresses, a copy of your state-issued identification card, and a recent utility bill, bank statement or insurance statement.

Additional Free Resources: You can obtain information from the consumer reporting agencies, the FTC, or from your respective state Attorney General about fraud alerts, security freezes, and steps you can take toward preventing identity theft. You may report suspected identity theft to local law enforcement, including to the FTC or to the Attorney General in your state.
