Re: Notification of a Data Security Incident

Dear Attorney General MacDonald:

We represent CenLA Federal Credit Union (“CenLA FCU”) in connection with a recent incident that may have impacted the personal information of one (1) New Hampshire resident, and we provide this notice on behalf of CenLA FCU pursuant to N.H. REV. STAT. ANN. § 359-C:20. This notice will be supplemented, if necessary, with any new significant facts discovered subsequent to its submission. While CenLA FCU is notifying you of this incident, CenLA FCU does not waive any rights or defenses relating to the incident or this notice, or the applicability of New Hampshire law on personal jurisdiction.

NATURE OF THE SECURITY INCIDENT OR UNAUTHORIZED USE OR ACCESS

CenLA FCU recently learned that an unauthorized party gained access to CenLA FCU’s environment. Upon discovering the incident, CenLA FCU immediately began an internal investigation, and it engaged a leading forensic firm to further investigate, determine whether any files had been accessed or exfiltrated in the course of the incident, and confirm the security of CenLA FCU’s systems. Through that investigation, CenLA FCU determined that, while the unauthorized party was in CenLA FCU’s environment, it downloaded certain files. CenLA FCU undertook a comprehensive review of these files and identified all members with personal information contained therein. On April 30, 2021, CenLA FCU determined that the impacted files included the name and Social Security Number of one (1) New Hampshire resident. At this point, CenLA FCU is not aware of any fraud or identity theft to any individual as a result of this incident. Nevertheless, CenLA FCU is notifying all individuals whose personal information was downloaded.



NUMBER OF NEW HAMPSHIRE RESIDENTS AFFECTED

The incident may have impacted one (1) New Hampshire resident. CenLA FCU is mailing notification letters to the impacted individuals today, May 28, 2021, via first-class United States mail. The letter includes an offer for one (1) year of complimentary credit monitoring. Enclosed is a sample of the letter being sent.

STEPS TAKEN RELATING TO THE INCIDENT

Upon learning of the incident, CenLA FCU promptly retained a forensic security firm to investigate the incident. CenLA FCU also worked to restore all of its systems and the information on those systems. Upon determining that an unauthorized third party had downloaded certain files stored on its systems, CenLA FCU reviewed the contents of those files and identified individuals with personal information contained therein. As noted, CenLA FCU is notifying these individuals and offering them complimentary credit monitoring. Since the incident, CenLA FCU has also reviewed its security protocols and assessed how it can further strengthen its systems to prevent a similar incident from occurring in the future.

The protection and privacy of your personal information is one of our highest priorities at CenLA Federal Credit Union ("CenLA FCU"). Because of this, we are writing to make you aware of a recent data security incident.

We recently learned that an unauthorized third party gained accesses to our computer network. Upon identifying the issue, we began an internal investigation and hired a leading computer forensics firm to examine our network and confirm the security of our computer systems. Based on that investigation, we learned that while the unauthorized party was in our network it had the ability to view and download certain documents. On April 30, 2021, we determined that these documents contained your name, together with your <<b2b_text_1(DataElements)>>.

At this point, we are not aware of any fraudulent activity or misuse of anyone's information as a result of the incident. Nonetheless, we are writing to alert you of the incident and to encourage you to diligently monitor your personal accounts. We are also offering you a complimentary one-year membership of Experian IdentityWorksSM Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on immediate identification and resolution of identity theft. IdentityWorks Credit 3B is completely free to you, and enrolling in this program will not hurt your credit score. **For more information on identity theft prevention and IdentityWorks Credit 3B, including instructions on how to activate your complimentary one-year membership, please see the additional information provided in this letter.** Out of an abundance of caution, CenLA FCU may also re-issue new debit (and credit) cards to certain members affected by this incident. The card(s) for those members will arrive through the mail within the next few weeks.

We value the trust you place in us to protect your privacy, take our responsibility to safeguard personal information seriously, and apologize for any inconvenience or concern this incident might cause. Fraud Alerts: You may want to consider placing a fraud alert on your credit report. A fraud alert is free and will stay on your credit report for one (1) year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. To place a fraud alert on your credit report, contact any of the three national credit reporting agencies using the contact information listed above. Credit and Security Freezes: You may have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company.
