Re: Notice of Data Event

Dear Sir or Madam:

We represent C.H. Briggs located at 2047 Kutztown Rd, Reading, PA 19605, and are writing to notify your office of an incident that may affect the security of some personal information relating to one (1) New Hampshire resident. This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, C.H. Briggs does not waive any rights or defenses regarding the applicability of New Hampshire law, the applicability of the New Hampshire data event notification statute, or personal jurisdiction.

Nature of the Data Event

On or about November 11, 2020, C.H. Briggs became aware of suspicious activity in its IT environment and initiated an investigation. As part of the investigation, which was conducted by third-party forensic specialists, it was determined that a number of email accounts were subject to unauthorized access between August 2020 and November 2020. C.H. Briggs therefore undertook a comprehensive review of the contents of the affected accounts to determine what information was present. CH Briggs then had to conduct a lengthy review of its internal records to locate mailing addresses for impacted individuals which was largely completed on August 16, 2021. Through the review, C.H. Briggs determined that the personal information of certain individuals was present in the relevant emails at the time of the incident, and thus potentially accessible. The information that could have been subject to unauthorized access includes name and financial account number.

Notice to New Hampshire Resident

On November 10, 2021, C.H. Briggs provided written notice of this incident to all affected individuals which includes one (1) New Hampshire resident. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, C.H. Briggs moved to investigate and respond to the incident, assess the security of its systems, and notify potentially affected individuals. C.H. Briggs also implemented additional safeguards. C.H. Briggs is providing individuals whose personal information was potentially affected by this incident with access to credit monitoring through Kroll for one (1) year at no cost to the individuals.

Additionally, C.H. Briggs is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. C.H. Briggs is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud. CH Briggs is also reporting this to regulators as required.

Notice of Data Security Incident

C.H. Briggs writes to make you aware of an incident that may affect some of your information. Although we have no evidence of misuse of your information, this letter provides details of the incident, our investigation, and steps you can take to help protect your information should you feel it is appropriate to do so.

What Happened? On November 11, 2020, C.H. Briggs became aware of suspicious activity in its IT environment and initiated an investigation. As part of the investigation, which was conducted by third-party forensic specialists, it was determined that a number of email accounts were subject to unauthorized access between August 2020 and November 2020. C.H. Briggs therefore undertook a comprehensive review of the contents of the affected accounts to determine what information was present. CH Briggs then had to conduct a lengthy review of its internal records to locate mailing addresses for impacted individuals which was largely completed on August 16, 2021. Through the review, C.H. Briggs determined that information related to you was present in the relevant emails at the time of the incident, and thus potentially accessible.

What We Are Doing. C.H. Briggs takes the security of information in its care very seriously. Upon learning of this issue, we immediately took steps to secure the email accounts and conducted a diligent investigation to confirm the nature and scope of the incident. We arranged to have Kroll provide identity monitoring services to you for one (1) year at no cost to you as an added precaution. Please review the enclosed Steps You Can Take to Help Protect Personal Information for instructions on how to activate these services.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. We further encourage you to enroll to receive the complimentary identity monitoring services being provided by CH Briggs.

Activate Identity Monitoring

To help relieve concerns and restore confidence following this incident, we have secured the services of Kroll to provide identity monitoring to you at no cost for one year. Kroll is a global leader in risk mitigation and response, and their team has extensive experience helping people who have sustained an unintentional exposure of confidential data. Your identity monitoring services include Credit Monitoring, Fraud Consultation, and Identity Theft Restoration.

You have been provided with access to the following services from Kroll:

Single Bureau Credit Monitoring

You will receive alerts when there are changes to your credit data—for instance, when a new line of credit is applied for in your name. If you do not recognize the activity, you'll have the option to call a Kroll fraud specialist, who will be able to help you determine if it is an indicator of identity theft.

Fraud Consultation

You have unlimited access to consultation with a Kroll fraud specialist. Support includes showing you the most effective ways to protect your identity, explaining your rights and protections under the law, assistance with fraud alerts, and interpreting how personal information is accessed and used, including investigating suspicious activity that could be tied to an identity theft event.

Identity Theft Restoration

If you become a victim of identity theft, an experienced Kroll licensed investigator will work on your behalf to resolve related issues. You will have access to a dedicated investigator who understands your issues and can do most of the work for you. Your investigator will be able to dig deep to uncover the scope of the identity theft, and then work to resolve it.

Kroll's activation website is only compatible with the current version or one version earlier of Chrome, Firefox, Safari and Edge.

To receive credit services, you must be over the age of 18 and have established credit in the U.S., have a Social Security number in your name, and have a U.S. residential address associated with your credit file.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;

4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.

You may have additional rights under the Fair Credit Reporting Act not summarized here.
