Re: Notice of Data Breach

Dear Attorney General:

We are providing this notice to you pursuant to Section 359-C:20 (I) (b) of the New Hampshire Revised Statutes.

Synopsis of the Events Surrounding the Breach

On or about January 30, 2020, our company and its related European parent (Bouygues Construction) and its U.S. subsidiaries became aware that its computer and IT systems had been infected with a ransomware virus.

The ransomware virus potentially allowed the hackers access to the personally identifiable information ("PII") of more than 4 of our New Hampshire-resident employees. Such PII includes birthdates, social security numbers, bank account information, and medical and health insurance information.

What we are Doing

Our company is in the process of sending out notices to its employees that are resident in New Hampshire, informing them of the data breach. This process should be complete in about 2 weeks. Our company also filed a complaint with the relevant local authorities in Europe and is working with them to identify the origin of the ransomware virus. Further, our company has shut down its information systems to prevent any further propagation of the virus. Our company is also in the process of testing those systems before bringing them back on-line.
