**Re: Notice of Data Event**

To Whom It May Concern:

We represent the County of Cumberland, PA (“County of Cumberland”) located at 16 West High Street, Suite 301, Carlisle, PA, 17013, and are writing to notify your office of an incident that may affect the security of certain personal information relating to one (1) New Hampshire residents. This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, the County of Cumberland does not waive any rights or defenses regarding the applicability of New Hampshire law, the applicability of the New Hampshire data event notification statute, or personal jurisdiction.

**Nature of the Data Event**

On October 4, 2023, the County of Cumberland discovered suspicious activity related to an employee’s email account. The County of Cumberland immediately launched an investigation, with the assistance of third-party forensic specialists, to determine the nature and scope of the activity. Their investigation determined that there was unauthorized access to an email account on October 4, 2023 for approximately ninety (90) minutes. Thereafter, the County of Cumberland undertook a comprehensive and time-intensive review of the contents of the email account to determine what information was contained therein and to whom it related. On January 9, 2024, the County of Cumberland finalized this review and determined that certain sensitive information was located within the impacted account at the time of the unauthorized access.

The information that could have been subject to unauthorized access for New Hampshire residents includes

### **Notice to New Hampshire Resident**

On February 14, 2024, the County of Cumberland provided written notice of this incident to one (1) New Hampshire resident. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

### **Other Steps Taken and To Be Taken**

Upon discovering the event, the County of Cumberland moved quickly to investigate and respond to the incident, assess the security of the County of Cumberland systems, and identify potentially affected individuals. The County of Cumberland is also working to implement additional safeguards and training to its employees. The County of Cumberland is providing access to credit monitoring services for , through Experian IdentityWorks<sup>SM</sup>, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, the County of Cumberland is providing impacted individuals with guidance on how to better protect against identity theft and fraud. The County of Cumberland is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

The County of Cumberland is providing written notice of this incident to relevant state regulators, as necessary.

## NOTICE OF [Extra4 -Variable Heading]

Dear Sample A. Sample:

The County of Cumberland, PA (“County of Cumberland”) is writing to inform you of a recent incident that may impact the security of some of your personal information. While we are unaware of any attempted or actual misuse of your information, we are providing you with information about the incident, our response, and steps you may take to protect against any misuse of your information, should you feel it necessary to do so.

**What Happened?** On October 4, 2023, County of Cumberland discovered suspicious activity related to an employee’s email account. We immediately launched an investigation, with the assistance of third-party forensic specialists, to determine the nature and scope of the activity. Our investigation determined that there was unauthorized access to an email account on October 4, 2023 for approximately ninety (90) minutes. Thereafter, the County of Cumberland undertook a comprehensive and time-intensive review of the contents of the email account to determine what information was contained therein and to whom it related. On January 9, 2024, we finalized this review and determined that information related to you was located within the impacted account at the time of the unauthorized access.

**What Information Was Involved?** The information contained in the impacted accounts included your [Extra1] (Data Elements Impacted)].

**What We Are Doing.** The County of Cumberland takes the confidentiality, privacy, and security of information in its care very seriously. Upon discovering the issue, we immediately commenced an investigation to confirm the nature and scope, and to identify what information could have been affected.

As an added precaution, we are offering you access to ## months of complimentary credit monitoring and identity protection services through Experian at no cost to you. A description of the services and instructions on how to enroll can be found within the enclosed *Steps You Can Take to Protect Personal Information*. Please note that you must complete the enrollment process yourself as we are not permitted to enroll you in these services.

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors over the next . We further encourage you to enroll in the complementary services being provided through Experian.

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General.
