Re: Des Moines Area Community College – Incident Notification

Dear Attorney General MacDonald:

McDonald Hopkins PLC represents Des Moines Area Community College. I am writing to provide notification of an incident at Des Moines Area Community College that may affect the security of personal information of approximately one (1) New Hampshire resident. Des Moines Area Community College's investigation is ongoing, and this notification will be supplemented with any new or significant facts or findings subsequent to this submission, if any. By providing this notice, Des Moines Area Community College does not waive any rights or defenses regarding the applicability of New Hampshire law or personal jurisdiction.

Des Moines Area Community College recently learned that meeting minutes that were available online from some meetings that were held from 1981-1986 and 1993 contained a limited number of students' Social Security numbers. The Social Security numbers were historically used by Des Moines Area Community College as student identification numbers and were identified as student identification numbers in the posted minutes. The minutes were posted online between December 2019 and May 8, 2020 as part of Des Moines Area Community College's efforts to digitize historical records. Upon discovering the issue, Des Moines Area Community College immediately had the records taken down and launched an investigation in consultation with outside data privacy professionals who regularly investigate and analyze these types of situations. Based on its comprehensive investigation and document review, which concluded on October 7, 2020, Des Moines Area Community College discovered that the affected resident's Social Security number was among those contained within the meeting minutes.

To date, Des Moines Area Community College is not aware of any reports of identity fraud or improper use of any information as a direct result of this incident. The data was not in a location that would greatly attract interest. Nevertheless, out of an abundance of caution, Des Moines Area Community College wanted to inform you (and the affected resident) of the incident and to explain the steps that it is taking to help safeguard the affected resident against

identity fraud. Des Moines Area Community College is providing the affected resident with written notification of this incident commencing on or about October 30, 2020 in substantially the same form as the letter attached hereto. Des Moines Area Community College is offering the affected resident a complimentary one-year membership with a credit monitoring service. Des Moines Area Community College is advising the affected resident about the process for placing fraud alerts and/or security freezes on his/her credit files and obtaining free credit reports. The affected resident is also being provided with the contact information for the consumer reporting agencies and the Federal Trade Commission.

At Des Moines Area Community College, protecting the privacy of personal information is a top priority. Des Moines Area Community College is committed to maintaining the privacy of personal information in its possession and has taken many precautions to safeguard it. Des Moines Area Community College continually evaluates and modifies its practices and internal controls to enhance the security and privacy of personal information.

I am writing with important information regarding a recent security incident. The privacy and security of the personal information we maintain is of the utmost importance to Des Moines Area Community College. We wanted to provide you with information about the incident, explain the services we are making available to you, and let you know that we continue to take significant measures to protect your information.

What Happened?

We recently learned that Des Moines Area Community College meeting minutes that were available online from some meetings that were held from 1981-1986 and 1993 contained a limited number of students' Social Security numbers. The Social Security numbers were historically used by Des Moines Area Community College as student identification numbers and were identified as student identification numbers in the posted minutes. The minutes were posted online between December 2019 and May 8, 2020 as part of Des Moines Area Community College's efforts to digitize historical records.

What We Are Doing.

Upon discovering the issue, we immediately had the records taken down and launched an investigation in consultation with outside data privacy professionals who regularly investigate and analyze these types of situations.

What Information Was Involved?

Based on our comprehensive investigation and document review, which concluded on October 7, 2020, we discovered that your Social Security number was among those contained within the meeting minutes.

What You Can Do.

To date, we are not aware of any reports of identity fraud or improper use of your or any other person's information as a direct result of this incident. The data was not in a location that would greatly attract interest. However, out of an abundance of caution, we wanted to make you aware of the incident, explain the services we are making available to help safeguard you against identity fraud, and suggest steps that you should take as well. To protect you from potential misuse of your information, we are offering a complimentary one-year membership of Experian IdentityWorksSM Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on immediate identification and resolution of identity theft. IdentityWorks Credit 3B is completely free to you and enrolling in this program will not hurt your credit score. For more information on identity theft prevention and IdentityWorks Credit 3B, including instructions on how to activate your complimentary one-year membership, please see the additional information provided in this letter.

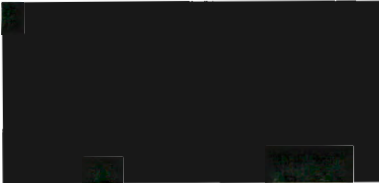

2. Placing a Fraud Alert on Your Credit File.

Whether or not you choose to use the complimentary 12 month credit monitoring services, we recommend that you place an initial one-year "Fraud Alert" on your credit files, at no charge. A fraud alert tells creditors to contact you personally before they open any new accounts. To place a fraud alert, call any one of the three major credit bureaus at the numbers listed below. As soon as one credit bureau confirms your fraud alert, they will notify the others.

3. Consider Placing a Security Freeze on Your Credit File.

If you are very concerned about becoming a victim of fraud or identity theft, you may request a "Security Freeze" be placed on your credit file, at no charge. A security freeze prohibits, with certain specific exceptions, the consumer reporting agencies from releasing your credit report or any information from it without your express authorization. You may place a security freeze on your credit report by contacting all three nationwide credit reporting companies at the numbers below and following the stated directions or by sending a request in writing, by mail, to all three credit reporting companies:

In order to place the security freeze, you'll need to supply your name, address, date of birth, Social Security number and other personal information. After receiving your freeze request, each credit reporting company will send you a confirmation letter containing a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

If your personal information has been used to file a false tax return, to open an account or to attempt to open an account in your name or to commit fraud or other crimes against you, you may file a police report in the City in which you currently reside.

If you do place a security freeze *prior* to enrolling in the credit monitoring service as described above, you will need to remove the freeze in order to sign up for the credit monitoring service. After you sign up for the credit monitoring service, you may refreeze your credit file.

4. Obtaining a Free Credit Report.

Under federal law, you are entitled to one free credit report every 12 months from each of the above three major nationwide credit reporting companies. Call **1-877-322-8228** or request your free credit reports online at **www.annualcreditreport.com**. Once you receive your credit reports, review them for discrepancies. Identify any accounts you did not open or inquiries from creditors that you did not authorize. Verify all information is correct. If you have questions or notice incorrect information, contact the credit reporting company.

5. Additional Helpful Resources.

Even if you do not find any suspicious activity on your initial credit reports, the Federal Trade Commission (FTC) recommends that you check your credit reports periodically. Checking your credit report periodically can help you spot problems and address them quickly.

If you find suspicious activity on your credit reports or have reason to believe your information is being misused, call your local law enforcement agency and file a police report. Be sure to obtain a copy of the police report, as many creditors will want the information it contains to absolve you of the fraudulent debts. You may also file a complaint with the FTC by contacting them on the web at www.ftc.gov/idtheft, by phone at 1-877-IDTHEFT (1-877-438-4338), or by mail at Federal Trade Commission, Consumer Response Center, 600 Pennsylvania Avenue, NW, Washington, DC 20580. Your complaint will be added to the FTC's Identity Theft Data Clearinghouse, where it will be accessible to law enforcement for their investigations. In addition, you may obtain information from the FTC about fraud alerts and security freezes.
