Re: Incident Notification

Dear Attorney General MacDonald:

We are writing on behalf of our client, Douglas Elliman Property Management (“DEPM”), to notify you of a data security incident.

On April 7, 2021, DEPM detected suspicious activity on its IT systems. Upon identifying this suspicious activity, DEPM immediately took steps to protect and secure its systems, launched an investigation, and notified law enforcement. The investigation confirmed that this incident was limited to DEPM’s IT systems and did **not** involve Douglas Elliman’s real estate brokerage and development marketing businesses or any other divisions, all of which have separate IT systems from DEPM.

Through its investigation, DEPM determined that an unauthorized party gained access to its IT network between the dates of April 5, 2021 and April 7, 2021. On April 9, 2021, DEPM’s investigation determined that the unauthorized party may have accessed certain files on DEPM’s systems that contained information pertaining to owners and others in buildings managed by DEPM. This information may have included names in combination with Social Security numbers, driver’s license numbers, passport numbers, and/or financial information.

Beginning on April 23, 2021, DEPM will mail notification letters via United States Postal Service First-Class mail to seven New Hampshire residents. A copy of the notification letter is enclosed.¹ DEPM has established a toll-free, incident response line to answer questions about the

incident from notice letter recipients. DEPM is also offering notice recipients complimentary memberships to Experian, which include credit monitoring and fraud protection services.

To help prevent something like this from happening in the future, DEPM is continuing to enhance its security protocols. Please do not hesitate to contact me if you have any questions.

Douglas Elliman Property Management (“DEPM”) is committed to protecting the confidentiality of the information we maintain. We are writing to inform you of a data security incident that disrupted the operations of our IT systems and may have involved some of your information. This notice explains the incident, measures we have taken since and steps you may take in response.

On April 7, 2021, DEPM detected suspicious activity on our IT systems. Upon identifying this suspicious activity, we immediately took steps to protect and secure our systems, launched an investigation, and notified law enforcement. DEPM’s investigation determined that the incident did **not** involve unauthorized access to ClickPay, which is a third-party service. In addition, the investigation confirmed that this incident was limited to DEPM’s IT systems and did **not** involve Douglas Elliman’s real estate brokerage and development marketing businesses or any other divisions, all of which have separate IT systems from DEPM.

Through our investigation, we determined that an unauthorized party gained access to our IT network between the dates of April 5, 2021 and April 7, 2021. The investigation further determined that the unauthorized party accessed certain files that contained information pertaining to owners and others in buildings managed by DEPM.

At this time, our investigation cannot rule out the possibility that files containing some of your information may have been subject to unauthorized access. This information may have included your name, date of birth, mailing address, Social Security number, driver’s license number, passport number, and financial information.

To date, DEPM is not aware of any individual who has experienced identity theft as a result of this incident. However, out of an abundance of caution, and because we take this incident seriously, we are offering you a complimentary one-year membership in Experian’s IdentityWorksSM. This product helps detect possible misuse of your information and provides you with identity protection support focused on immediate identification and resolution of identity theft. IdentityWorks is free and enrolling in this program will not affect your credit score. **For more information on IdentityWorks, including instructions on how to activate your complimentary one-year membership and steps you can take to protect your information, please see the pages that follow this letter.**

We take this matter very seriously and are continuing to enhance our security protocols to help prevent a similar incident from occurring in the future. We deeply regret any inconvenience or concern this incident may cause.

ADDITIONAL STEPS YOU CAN TAKE

We remind you it is always advisable to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. Obtain a copy of the police report in case you are asked to provide copies to creditors to correct your records. Contact information for the Federal Trade Commission is as follows:

Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years. To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report. For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. For information and instructions to place a security freeze, contact each of the credit reporting agencies at the addresses below:

You'll need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.

Rhode Island: This incident involves **21** individuals in Rhode Island. Under Rhode Island law, you have the right to file and obtain a copy of a police report. West Virginia: You have the right to ask that nationwide consumer reporting agencies place “fraud alerts” in your file to let potential creditors and others know that you may be a victim of identity theft, as described above. You also have a right to place a security freeze on your credit report, as described above.

A Summary of Your Rights Under the Fair Credit Reporting Act: The federal Fair Credit Reporting Act (FCRA) promotes the accuracy, fairness, and privacy of information in the files of consumer reporting agencies. There are many types of consumer reporting agencies, including credit bureaus and specialty agencies (such as agencies that sell information about check writing histories, medical records, and rental history records). Your major rights under the FCRA are summarized below. - You must be told if information in your file has been used against you.
- You have the right to know what is in your file.
- You have the right to ask for a credit score.
- You have the right to dispute incomplete or inaccurate information.
- Consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information.
- Consumer reporting agencies may not report outdated negative information.
- Access to your file is limited.
- You must give your consent for reports to be provided to employers.
- You may limit “prescreened” offers of credit and insurance you get based on information in your credit report.
- You have a right to place a “security freeze” on your credit report, which will prohibit a consumer reporting agency from releasing information in your credit report without your express authorization.
- You may seek damages from violators.
- Identity theft victims and active duty military personnel have additional rights.
