*Re: Incident Notification*

Dear Attorney General MacDonald:

We are writing on behalf of our client, E & J Gallo Winery (“Gallo”), to notify your office of a security incident.

Gallo experienced a cyber incident designed to encrypt files and disrupt business operations. Upon discovery of the incident on November 17, 2020, Gallo activated its response plan and cybersecurity forensics firms were engaged to assist with the response. The investigation determined that an unauthorized party gained access to Gallo systems between November 7, 2020 and November 17, 2020. During that time, certain information on some of Gallo’s servers may have been accessed or acquired. On January 15, 2021, it was determined that names, Social Security numbers, driver’s license numbers, and/or financial account number(s) belonging to Gallo employees, former employees and applicants for employment may have been accessed.

On February 19, 2021, Gallo commenced mailing notification letters to the individuals whose information may have been involved, including 43 New Hampshire residents whose personal information may have been involved in the incident. A copy of the notification letter is attached. Gallo is offering a one-year membership in complimentary credit monitoring and identity theft protection services through Experian to affected individuals. Gallo has also established a dedicated call center that individuals can call with questions about the incident or enrolling in credit monitoring.


To help prevent something like this from happening in the future, Gallo has implemented additional measures to enhance its existing security protocols.

An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

***Credit or Security Freezes:*** You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

***How do I place a freeze on my credit reports?*** There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. Your major rights under the FCRA are summarized below. - You must be told if information in your file has been used against you.
- You have the right to know what is in your file.
- You have the right to ask for a credit score.
- You have the right to dispute incomplete or inaccurate information.
- Consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information.
- Consumer reporting agencies may not report outdated negative information.
- Access to your file is limited.
- You must give your consent for reports to be provided to employers.
- You may limit "prescreened" offers of credit and insurance you get based on information in your credit report.
- You have a right to place a "security freeze" on your credit report, which will prohibit a consumer reporting agency from releasing information in your credit report without your express authorization.
- You may seek damages from violators.
- Identity theft victims and active duty military personnel have additional rights.
