Re: Notice of Data Event

To Whom It May Concern:

We represent East Shore Specialty Foods (“ESSF”), located at 643 Cardinal Lane, Hartland, WI 53029, and are writing to notify your office of an incident that may affect the security of certain personal information relating to approximately five (5) New Hampshire residents. By providing this notice, ESSF does not waive any rights or defenses regarding the applicability of New Hampshire law, the applicability of the New Hampshire data event notification statute, or personal jurisdiction.

Nature of the Data Event

On or about May 3, 2023, CV3 learned that an unauthorized party obtained access to its systems between November 24, 2021 and December 14, 2022. Upon learning of the incident, CV3 conducted an investigation alongside third-party cybersecurity experts to assess whether any cardholder data was compromised as a result of the access. As a result of the investigation, CV3 discovered that cardholder data collected on ESSF’s behalf was potentially accessed or acquired by an unauthorized party as a result of the incident.

CV3 notified ESSF on June 6, 2023. Upon notice, ESSF immediately launched an investigation into the event. Following confirmation of the information impacted, ESSF worked to confirm the population, confirm proper contact information and notify their customers. Please note that all credit card information was accessed through the outside vendor, CV3. This event did not impact ESSF’s internal systems.

The information that could have been subject to unauthorized access includes

Notice to New Hampshire Residents

On or about October 26, 2023, ESSF provided written notice of this incident to approximately five (5) New Hampshire residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, ESSF moved quickly to investigate and respond to the incident and identify potentially affected individuals. ESSF is providing access to credit monitoring services for one (1) year, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, ESSF is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. ESSF is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

ESSF is providing written notice of this incident to relevant state regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion.

NOTICE OF DATA BREACH

Dear Sample A. Sample:

The privacy and security of the personal information we maintain is of the utmost importance to East Shore Specialty Foods. We want to notify you of an incident that impacted our third-party e-commerce platform, CommerceV3 (“CV3”), that may have involved some of your personal information. We are writing to provide you with information regarding the incident and steps you can take to protect your personal information.

What Happened? On May 3, 2023, CV3 learned that an unauthorized party obtained access to its systems between November 24, 2021 and December 14, 2022. Upon learning of the incident, CV3 conducted an investigation alongside third-party cybersecurity specialists to assess whether any cardholder data was compromised as a result of the access. CV3 notified us of the event and the impact to card information for certain customers of ours. Since that time, we have worked to confirm the population, confirm proper contact information and notify our customers.

What Information Was Involved? As a result of CV3’s incident, the information related to you that was stored on the impacted system and may have been accessed includes

What We Are Doing. We take the security of your information seriously. As part of our ongoing commitment to the privacy of personal information in our care, we are working to review our existing policies and procedures and to implement additional administrative and technical safeguards. Please note that all credit card information was accessed through the outside vendor, CV3. This event did not impact ESSF’s internal systems.

While there is currently no evidence that your information has been misused, East Shore Specialty Foods is offering credit monitoring to all of its potentially affected customers through Experian. For enrollment instructions, please review the information contained in the attached *Steps You Can Take to Help Protect Your Information*.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity. You may also review the information contained in the attached *Steps You Can Take to Help Protect Your Information*. There you will find more information on the credit monitoring and identity restoration services we are making available to you. We encourage you to activate these services as we are not able to act on your behalf to activate them for you.

Enroll in Monitoring Services

To help protect your identity, we are offering complimentary access to Experian IdentityWorksSM for [Extra2] months.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them. Consumers have the right to file a police report if they ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement and the relevant state Attorney General. This notice has not been delayed by law enforcement.

Further, pursuant to the Fair Credit Reporting Act, the consumer reporting bureaus must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to consumers' files is limited; consumers must give consent for credit reports to be provided to employers; consumers may limit "prescreened" offers of credit and insurance based on information in their credit report; and consumers may seek damages from violators. Consumers may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
