Dear Attorney General Foster:

We represent Engle Martin & Associates (“Engle Martin”) with respect to a data security incident involving the potential exposure of certain personally identifiable information described in more detail below. Engle Martin is an insurance claims administrator based in Atlanta, Georgia.

1. Nature of security incident.

Engle Martin recently learned of suspicious activity associated with an employee’s email account. Out of an abundance of caution, Engle Martin hired an independent computer forensics company to investigate and review Engle Martin’s systems to determine if there had been a compromise of any Engle Martin systems. The forensic investigation determined that an unauthorized user had obtained access to the email accounts of a limited number of Engle Martin employees. On January 3, 2018, the forensic investigator informed Engle Martin that these email accounts contained information that may have included the name, address, Social Security number, bank account or credit card information, and health insurance information for a limited number of employees and individuals who had submitted claims. .

2. Number of New Hampshire residents affected.

Four (4) New Hampshire residents were notified of the incident. A notification letter was sent to the affected individuals on February 14, 2018 via regular mail (a copy of the form notification letter is enclosed).

3. Steps taken or plan to take relating to the incident.

Steps have been taken to help prevent a similar occurrence in the future. Passwords to all Engle Martin personnel e-mail accounts were changed and the compromised e-mail accounts were secured. To help prevent such an incident from reoccurring, additional e-mail security enhancements were implemented and additional training was provided to employees on


recognizing and appropriately responding to suspicious emails and other security threats. Additionally, affected individuals were offered credit monitoring and identity restoration services free of charge for one year through Kroll. The credit reporting agencies have also been notified of this incident.

Notice of Security Incident

We are writing to inform you of a data security incident experienced by Engle Martin & Associates, Inc. ("Engle Martin") that may have resulted in the exposure of your personal information, including your name, Social Security number, and medical information. This security incident involved the compromise of a limited number of Engle Martin email accounts and their contents. We value and respect the privacy of your information, and we sincerely apologize for any concern or inconvenience this may cause you. This letter contains information about steps you can take to protect your information, and resources we are making available to help you.

1. What happened and what information was involved:

Engle Martin recently received notice from one of its business partners about a suspicious email they received involving an Engle Martin employee. Out of an abundance of caution, we hired a nationally respected computer forensics company to investigate and review our systems to determine if there had been a compromise of any Engle Martin systems. The forensic investigator notified us that an unauthorized user had obtained access to the email addresses of a limited number of Engle Martin employees. On January 3, 2018, our forensic vendor alerted us that these email accounts contained information that may have included your name, address, Social Security number, health insurance information, or other demographic information.

2. What we are doing and what you can do:

While there is no indication your information has been misused, we have secured the services of Kroll to provide identity monitoring at no cost to you for one year. Kroll is a global leader in risk mitigation and response, and their team has extensive experience helping people who have sustained an unintentional exposure of confidential data. Your identity monitoring services include Credit Monitoring, Fraud Consultation, and Identity Theft Restoration.

You have until May 10, 2018 to activate your identity monitoring services.



U.S. State Notification Requirements

For residents of Hawaii, Michigan, Missouri, Virginia, Vermont, and North Carolina:

It is recommended by state law that you remain vigilant for incidents of fraud and identity theft by reviewing credit card account statements and monitoring your credit report for unauthorized activity.

For residents of Illinois, Iowa, Maryland, Missouri, North Carolina, Oregon, and West Virginia:

It is required by state laws to inform you that you may obtain a copy of your credit report, free of charge, whether or not you suspect any unauthorized activity on your account. You may obtain a free copy of your credit report by contacting any one or more of the following national consumer reporting agencies:

For residents of Iowa:

State law advises you to report any suspected identity theft to law enforcement or to the Attorney General.

For residents of Oregon:

State laws advise you to report any suspected identity theft to law enforcement, as well as the Federal Trade Commission.

For residents of Maryland, Illinois, North Carolina, and Rhode Island:

You can obtain information from the Maryland, North Carolina, and Rhode Island Offices of the Attorneys General and the Federal Trade Commission about fraud alerts, security freezes, and steps you can take toward preventing identity theft.

For residents of Massachusetts:

It is required by state law that you are informed of your right to obtain a police report if you are a victim of identity theft.

For residents of all states:

Fraud Alerts: You can place fraud alerts with the three credit bureaus at one of the three major credit bureaus by phone and also via Experian's or Equifax's website. A fraud alert tells creditors to follow certain procedures, including contacting you, before they open any new accounts or change your existing accounts. For that reason, placing a fraud alert can protect you, but also may delay you when you seek to obtain credit. The contact information for all three credit bureaus is below.

Monitoring: You should always remain vigilant and monitor your accounts for suspicious or unusual activity.

Security Freeze: You also have the right to place a security freeze on your credit report. A security freeze is intended to prevent credit, loans and services from being approved in your name without your consent. To place a security freeze on your credit report, you need to send a request to each consumer reporting agency by certified mail, overnight mail, or regular stamped mail. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. The consumer reporting agency may charge a fee of up to \$5.00 to place a freeze or lift or remove a freeze, but is free if you are a victim of identity theft or the spouse of a victim of identity theft, and you have submitted a valid police report relating to the identity theft incident to the consumer reporting agencies:
