**Re: Notice of Data Event**

To Whom It May Concern:

We represent Fincantieri Marine Group, LLC (“FMG”) located at 655 15<sup>th</sup> St. NW, Suite 450, Washington, DC 20005, and are writing to notify your office of an incident that may involve certain personal information relating to three (3) New Hampshire residents. This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, FMG does not waive any rights or defenses regarding the applicability of New Hampshire law, the applicability of the New Hampshire data event notification statute, or personal jurisdiction.

**Nature of the Data Event**

On or about April 12, 2023, FMG became aware of a cyberattack on its computer systems that included the encryption of certain files. FMG promptly took steps to secure its environment and began an investigation into the nature and scope of the incident. The investigation determined that, in connection with the incident, there was unauthorized access to certain systems in FMG’s environment between April 6, 2023, and April 12, 2023, and as a result, certain data stored on its systems were subject to unauthorized acquisition. FMG then undertook a comprehensive review of the affected data to confirm what information was impacted. On November 6, 2023, FMG determined that personal information relating New Hampshire residents was in the files at issue.

The personal information involved includes

### **Notice to New Hampshire Residents**

On or about January 5, 2024, FMG provided written notice of this incident to three (3) New Hampshire residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

### **Other Steps Taken and To Be Taken**

Upon discovering the event, FMG moved quickly to investigate and respond to the incident, assess the security of FMG systems, and identify potentially affected individuals. Further, FMG notified federal law enforcement regarding the event. FMG is also working to implement additional safeguards and training to its employees. FMG is providing access to credit monitoring services for \_\_\_\_\_, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, FMG is providing impacted individuals with guidance on how to better protect against identity theft and fraud. FMG is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

FMG is providing written notice of this incident to relevant regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion.

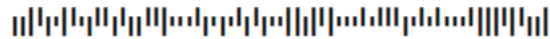

**NOTICE OF [Extra3]**

Dear Sample A. Sample:

Fincantieri Marine Group, LLC (“FMG”) writes to inform you of a recent incident that may involve some of your information. While we have no evidence of actual or attempted misuse of any of your information regarding this incident, this notice provides information about the incident, our response, what you can do to protect your information from possible misuse, and contact procedures for you to ask questions or obtain additional information about this incident.

**What Happened?** On or about April 12, 2023, FMG became aware of a cyberattack on our computer systems that included the encryption of certain files. We promptly took steps to secure our environment and began an investigation into the nature and scope of the incident. The investigation determined that, in connection with the incident, there was unauthorized access to certain systems in our environment between April 6, 2023, and April 12, 2023, and as a result, certain data stored on our systems was subject to unauthorized acquisition. We then undertook a comprehensive review of the affected data to confirm what information was impacted. On November 6, 2023, we determined that personal information relating to you was contained in the files.

**What Information Was Involved?** The investigation determined your name, and the following types of data were present in the files at issue: [Extra1][Extra2].

**What We Are Doing.** We take this incident and the security of information in our care seriously. Upon learning of this incident, we immediately secured our environment, investigated to determine the nature and scope of the incident, and notified law enforcement. We have also implemented additional technical safeguards to help prevent a similar incident in the future. ## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

## **Additional Information**

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement and the relevant state Attorney General. This notice has not been delayed by law enforcement.

Under Massachusetts law, you have the right to obtain any police report filed in regard to this incident. If you are the victim of identity theft, you also have the right to file a police report and obtain a copy of it.

Consumers may have additional rights under the Fair Credit Reporting Act not summarized here.
