Re: Incident Notification

Dear Attorney General Formella:

We are writing on behalf of our client, GATE Petroleum Company, to notify your office of a cybersecurity incident that involved one New Hampshire resident's information. GATE is located at 9540 San Jose Blvd., Jacksonville, Florida 32257.

On September 21, 2022, GATE detected suspicious activity on its computer network. GATE immediately began an investigation with the assistance of an external cybersecurity firm. The investigation determined that between September 20, 2022 and September 22, 2022, someone potentially accessed certain files within GATE's systems without authorization. GATE reviewed those files and, on October 12, 2022, determined that they contained the name and Social Security number for one New Hampshire resident.

On November 9, 2022, GATE will begin mail a notification letter via United States Postal Service First-Class mail to the New Hampshire resident pursuant to N.H. Rev. Stat. Ann. § 359-C:20.¹ A copy of the notification is enclosed. GATE is offering the New Hampshire resident one year of complimentary credit monitoring, fraud consultation, and identity theft restoration services through Experian. GATE has also established a dedicated call center for individuals to call with questions about the incident.

To help prevent a similar incident from occurring in the future, GATE has and will continue to take steps to enhance the security of its computer systems and the data GATE maintains.

GATE Petroleum Company is committed to ensuring the privacy and security of your personal information. As such, we want you to be aware of a recent incident that may involve some of that information. This letter explains the incident, measures we have taken, and some steps you may consider taking.

On September 21, 2022, we detected suspicious activity on our computer network. We immediately began an investigation with the assistance of an external cybersecurity firm. Our investigation determined that between September 20, 2022 and September 22, 2022, someone accessed certain files within our systems without authorization. In response, we moved as quickly as possible to close the access point and determine what, if any, information may have been involved. We reviewed those files and, on October 12, 2022, we determined that they contained your name as well your <<b2b_text_1 (data elements)>>.

It is always advisable to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity. To support you in your monitoring efforts, we are offering you a free one-year membership with Experian IdentityWorksSM Credit 3B. This product helps detect any misuse of your personal information and provides you with identity protection services that focus on immediate identification and resolution of any instance of identity theft. IdentityWorks is completely free to you and enrolling in this program will not affect your credit score. **For more information on IdentityWorks, including instructions on how to activate your complimentary one-year membership, as well as additional steps you can take to protect your information, please see the pages that follow this letter.**

We remind you it is always advisable to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity over the next 12–24 months. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. Obtain a copy of the police report in case you are asked to provide copies to creditors to correct your records. Contact information for the Federal Trade Commission is as follows:

Fraud Alerts and Credit or Security Freezes:

Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That is because most creditors need to see your credit report before they approve a new account. If they cannot see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. For information and instructions to place a security freeze, contact each of the credit reporting agencies at the addresses below:

You will need to supply your name, address, date of birth, Social Security number and other personal information. After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.

West Virginia: You have the right to ask that nationwide consumer reporting agencies place “fraud alerts” in your file to let potential creditors and others know that you may be a victim of identity theft, as described above. You also have a right to place a security freeze on your credit report, as described above.

A Summary of Your Rights Under the Fair Credit Reporting Act: The federal Fair Credit Reporting Act (FCRA) promotes the accuracy, fairness, and privacy of information in the files of consumer reporting agencies. There are many types of consumer reporting agencies, including credit bureaus and specialty agencies (such as agencies that sell information about check writing histories, medical records, and rental history records). Your major rights under the FCRA are summarized below. - You must be told if information in your file has been used against you.
- You have the right to know what is in your file.
- You have the right to ask for a credit score.
- You have the right to dispute incomplete or inaccurate information.
- Consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information.
- Consumer reporting agencies may not report outdated negative information.
- Access to your file is limited.
- You must give your consent for reports to be provided to employers.
- You may limit “prescreened” offers of credit and insurance you get based on information in your credit report.
- You have a right to place a “security freeze” on your credit report, which will prohibit a consumer reporting agency from releasing information in your credit report without your express authorization.
- You may seek damages from violators.
- Identity theft victims and active duty military personnel have additional rights.
