RE: Notice of Data Security Incident

Dear Attorney General MacDonald:

Our law firm, Nelson Mullins Riley & Scarborough LLP, One Financial Center, 35th Floor, Boston, MA 02111, represents Goody Clancy and Associates, Inc. ("Goody Clancy"), 420 Boylston Street, Boston, MA 02116, an architectural firm. Goody Clancy recently experienced an email data security incident which is detailed below.

Between June 30, 2020, and August 17, 2020, a company email account was accessed by an unknown individual without authorization. However, because of the limited nature of email activity logs, Goody Clancy was unable to establish which emails were viewed or downloaded during the period of unauthorized access.

Because Goody Clancy was unable to establish which emails were viewed or downloaded, it used a firm to review all available data within the email account, which, after addition and updating of contact information, was completed on October 23, 2020. The review revealed that some emails and attachments contained personal information. Although Goody Clancy is unaware of any actual access to or acquisition of any personal information and has no evidence of any attempted or actual misuse of personal information, it decided to proactively provide notice and two (2) years of identity monitoring without cost.

With respect to the two (2) New Hampshire residents, the personal information consisted of a first and last name and Social Security number. The resident will be notified by the enclosed letter post-marked November 4, 2020.

NOTICE OF DATA SECURITY INCIDENT

Goody Clancy & Associates, Inc. respects the privacy of your information, which is why we are writing to tell you about an email data security incident that may have exposed some personal information of a small number of individuals.

What Happened

Between June 30, 2020, and August 17, 2020, a company email account was accessed by an unknown individual without authorization. However, because of the limited nature of email activity logs, we were unable to establish which emails were viewed or downloaded during the period of unauthorized access.

Because we were unable to establish which emails were viewed or downloaded, we used a firm to review all available data within the email account, which, after addition and updating of contact information, was completed on October 23, 2020. The review revealed that some emails and attachments contained personal information. Although we are unaware of any actual access to or acquisition of your personal information and have no evidence of any attempted or actual misuse of your information, we have decided to proactively provide notice and two (2) years of identity monitoring without cost to you to give you the opportunity to protect yourself.

What Information Was Involved

As a result of this email incident, some of your personal information may have been accessed and acquired without authorization, which may have included your first and last name, <<Data Elements>>.

We are notifying you so you can take appropriate steps to protect your personal information.

What We Are Doing

To help relieve concerns following this incident, we have engaged TransUnion to provide identity monitoring at no cost to you for two (2) years. TransUnion is an industry leader and functions as a first point of contact for credit-related issues, which allows it to efficiently furnish timely notification about credit-related issues to individuals enrolled in its identity monitoring service.



Free Credit Report. It is recommended that you remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring your credit report for unauthorized activity over the next twenty-four months, and immediately report incidents of suspected identity theft to both your financial provider and law enforcement.

You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting agencies. You may also seek to have information relating to fraudulent transactions removed from your credit report. To order your annual free credit report, please visit www.annualcreditreport.com or call toll free at 1-877-322-8228.

You can also order your annual free credit report by mailing a completed Annual Credit Report Request Form (available from the U.S. Federal Trade Commission's ("FTC") website at www.consumer.ftc.gov) to: Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA 30348-5281.

For Colorado, Georgia, Maine, Maryland, New Jersey, Puerto Rico, and Vermont residents: You may obtain one or more (depending on the state) additional copies of your credit report, free of charge. You must contact each of the credit reporting agencies directly to obtain such additional report(s).

Fraud Alert. You may place a fraud alert in your file by calling one of the three nationwide credit reporting agencies above. A fraud alert tells creditors to follow certain procedures, including contacting you before they open any new accounts or change your existing accounts. For that reason, placing a fraud alert can protect you, but also may delay you when you seek to obtain credit.

Security Freeze. You have the ability to place a security freeze on your credit report free of charge.

A security freeze is intended to prevent credit, loans, and services from being approved in your name without your consent. To place a security freeze on your credit report, you may be able to use an online process, an automated telephone line, or a written request to any of the three credit reporting agencies listed above. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; (5) legible copy of a government issued identification card; (6) legible copy of a recent utility bill or bank or insurance statement that displays your name and current mailing address, and the date of issue; and (7) any applicable incident report or complaint filed with a law enforcement agency.

Federal Trade Commission and State Attorneys General Offices. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your home state. You may also contact these agencies for information on how to prevent or avoid identity theft.

Complimentary Two-Year *myTrueIdentity* Credit Monitoring Service

As a safeguard, we have arranged for you to enroll, at no cost to you, in an online credit monitoring service (*myTrueIdentity*) for two years provided by TransUnion Interactive, a subsidiary of TransUnion®, one of the three nationwide credit reporting companies.

How to Enroll: You can sign up online or via U.S. mail delivery

- To enroll in this service, go to the *myTrueIdentity* website at www.MyTrueIdentity.com and, in the space referenced as "Enter Activation Code," enter the 12-letter Activation Code <<**Insert Unique 12-letter Activation Code**>> and follow the three steps to receive your credit monitoring service online within minutes.
- If you do not have access to the Internet and wish to enroll in a similar offline, paper-based credit monitoring service, via U.S. mail delivery, please call the TransUnion Fraud Response Services toll-free hotline at **1-855-288-5422**. You can sign up for the online or offline credit monitoring service anytime between **now** and <<**Enrollment Deadline**>>. Due to privacy laws, we cannot register you directly. Please note that credit monitoring services might not be available for individuals who do not have a credit file with TransUnion or an address in the United States (or its territories) and a valid Social Security number. Enrolling in this service will not affect your credit score.

ADDITIONAL DETAILS REGARDING YOUR 24-MONTH COMPLIMENTARY CREDIT MONITORING SERVICE:

- Once you are enrolled, you will be able to obtain two years of unlimited access to your TransUnion credit report and credit score.
- The daily credit monitoring service will notify you if there are any critical changes to your credit file at TransUnion, including fraud alerts, new inquiries, new accounts, new public records, late payments, changes of address, and more.
