Re: Incident Notification

Dear Attorney General MacDonald:

We are writing on behalf of our client, HealthcareSource HR, Inc. (“HealthcareSource”), who in turn is writing on behalf of its client entities, to notify you of a data security incident.

HealthcareSource provides comprehensive talent management solutions to support the healthcare industry, including talent management software which allows prospective employees to apply for jobs with HealthcareSource’s healthcare clients.

On April 21, 2021, HealthcareSource discovered a misconfiguration in its talent management software, which temporarily allowed job applicants to potentially view other applicants’ information. Upon learning of this incident, HealthcareSource promptly corrected the software misconfiguration and launched an investigation. HealthcareSource’s investigation was unable to rule out the possibility that information relating to certain job applicants may have been viewable by other applicants between April 20, 2021 and April 21, 2021 due to the misconfiguration on its talent management software.

While the information potentially involved varied by applicant, HealthcareSource’s investigation determined that the viewable personal information relating to a New Hampshire resident may have included their name and Social Security number. To date, HealthcareSource is unaware of any misuse of any information as a result of this incident.

Beginning on May 26, 2021, HealthcareSource will mail a notification letter via United States Postal Service First-Class mail to the one applicant who is a New Hampshire resident, in accordance with N.H. Rev. Stat. Ann. § 359-C:20. A copy of the notification letter is enclosed.¹ HealthcareSource has established a toll-free, incident response line to answer questions about the incident from notice letter recipients. HealthcareSource is also offering notice recipients whose Social Security numbers or driver's license numbers may have been involved complimentary memberships to Experian, which include credit monitoring and fraud protection services.

To help prevent something like this from happening in the future, HealthcareSource is taking steps to further protect applicant information and is working to enhance its security practices.

HealthcareSource HR, Inc. (“HealthcareSource”) is committed to protecting the privacy and security of the information we maintain. HealthcareSource provides talent management software services to healthcare organizations. We are writing to notify you of a technical issue that may have involved some of the information you submitted when you applied for a job opening at <<b2b_text_1(ImpactedData1)>>, which uses HealthcareSource’s talent management software. This notice explains the technical issue, measures we have taken since and steps you may take in response.

What Happened: On April 21, 2021, HealthcareSource discovered a misconfiguration in our talent management software, which allowed job applicants to view other applicants’ information. Upon learning of this incident, HealthcareSource promptly corrected the software misconfiguration and launched an investigation. Through our investigation, we determined that the misconfiguration existed on our talent management software between the dates of April 20, 2021 and April 21, 2021. Our investigation could not rule out the possibility that some of your information may have been viewable to other job applicants during that time.

What Information Was Involved: Our investigation determined that the viewable information may have included your name in combination with your <<b2b_text_2(ImpactedData2)>>.

What We Are Doing: Upon learning of this, HealthcareSource promptly corrected the software misconfiguration. HealthcareSource is taking steps to further protect applicant information and is working to enhance our security practices.

What You Can Do: We encourage you to remain vigilant by reviewing your financial account statements for any unauthorized activity. If you see charges or activity you did not authorize, you should contact your financial institution immediately. Additionally, as a precaution, we have secured the services of Experian® to offer you a complimentary one-year membership of Experian’s IdentityWorksSM. This product helps detect possible misuse of your information and provides you with identity protection support focused on immediate identification and resolution of identity theft. We remind you it is always advisable to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years. To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report. For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. For information and instructions to place a security freeze, contact each of the credit reporting agencies at the addresses below:

You'll need to supply your name, address, date of birth, Social Security number and other personal information. After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request. If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.

A Summary of Your Rights Under the Fair Credit Reporting Act: The federal Fair Credit Reporting Act (FCRA) promotes the accuracy, fairness, and privacy of information in the files of consumer reporting agencies. There are many types of consumer reporting agencies, including credit bureaus and specialty agencies (such as agencies that sell information about check writing histories, medical records, and rental history records). Your major rights under the FCRA are summarized below. - You must be told if information in your file has been used against you.
- You have the right to know what is in your file.
- You have the right to ask for a credit score.
- You have the right to dispute incomplete or inaccurate information.
- Consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information.
- Consumer reporting agencies may not report outdated negative information.
- Access to your file is limited.
- You must give your consent for reports to be provided to employers.
- You may limit “prescreened” offers of credit and insurance you get based on information in your credit report.
- You have a right to place a “security freeze” on your credit report, which will prohibit a consumer reporting agency from releasing information in your credit report without your express authorization.
- You may seek damages from violators.
- Identity theft victims and active duty military personnel have additional rights.
