Re: Legal Notice of Potential Information Security Incident

Dear Sirs or Madams:

We write on behalf of our client, IMI Precision Engineering d/b/a Bimba Manufacturing (“Bimba”), to notify you of a security incident that may have resulted in the unauthorized access or acquisition of the personal information of 11 New Hampshire residents.

We were recently informed by our vendor that our third-party cloud service provider had a vulnerability on the server(s) that hosted one of our websites, Bimba.com. The vulnerability did not originate from our systems but from that of a third party. As a result of this vulnerability, an unauthorized user may have been able to access or acquire personal information of our customers.

Upon learning of the incident, we immediately began an investigation to determine how the security incident occurred and the scope of such incident. We also asked our vendor for additional information to enable us to fully investigate the incident.

Based on the information we have to date, the unauthorized user inserted malicious code into web files causing unencrypted copies of e-commerce transaction data to be diverted to the unauthorized user. As a result, the unauthorized user may have received personal information during timeframes beginning no earlier than August 21, 2020 and no later than November 13, 2020. While the investigation is ongoing, our vendor informed us that during this timeframe, 844 unique individuals made transactions on Bimba.com.

The personal information potentially accessed or acquired includes credit card number, expiration date, security number, customer name, and customer address for each of the transactions that occurred during the timeframe.

We are conducting a thorough review of the potentially affected records and continue to create and implement additional security measures designed to prevent a similar occurrence from happening again including changing suppliers. Our vendor has informed us that no further issues can affect our files and they are monitoring the site daily.

The vulnerability did not originate from our systems but from that of a third party. Upon learning of the incident, we immediately began an investigation and took additional security measures to remediate the vulnerability that apparently caused the incident. We also asked our vendor for additional information to enable us to fully investigate the incident.

Based on the information we have to date, the unauthorized user inserted malicious code into web files that may have caused unencrypted copies of e-commerce transaction data to be diverted to the unauthorized user. As a result, the unauthorized user may have received your personal information during timeframes beginning no earlier than August 21, 2020 and no later than November 13, 2020. While the investigation is ongoing, we encourage you to take the preventative measures outlined in this letter to help protect your information.

**What Information Was Involved**

The personal information potentially accessed or acquired by the unauthorized user includes your name, address, credit card number, expiration date, and security number.

**Free Credit Report.** We remind you to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. **Security Freeze.** Security freezes, also known as credit freezes, restrict access to your credit file, making it harder for identity thieves to open new accounts in your name. You can freeze and unfreeze your credit file for free. You also can get a free freeze for your children who are under 16. And if you are someone's guardian, conservator or have a valid power of attorney, you can get a free freeze for that person, too. How will these freezes work? Contact all three of the nationwide credit reporting agencies – Equifax, Experian, and TransUnion. If you request a freeze online or by phone, the agency must place the freeze within one business day. If you request a lift of the freeze, the agency must lift it within one hour. If you make your request by mail, the agency must place or lift the freeze within three business days after it gets your request. You also can lift the freeze temporarily without a fee.

Don't confuse freezes with locks. They work in a similar way, but locks may have monthly fees. If you want a free freeze guaranteed by federal law, then opt for a freeze, not a lock.

The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue.

**For New Mexico residents:** You may obtain a security freeze on your credit report to protect your privacy and ensure that credit is not granted in your name without your knowledge. You may submit a declaration of removal to remove information placed in your credit report as a result of being a victim of identity theft. You have a right to place a security freeze on your credit report or submit a declaration of removal pursuant to the Fair Credit Reporting and Identity Security Act.

**For Colorado and Illinois residents:** You may obtain information from the credit reporting agencies and the FTC about security freezes.

**Fraud Alerts.** A fraud alert tells businesses that check your credit that they should check with you before opening a new account. As of September 18, 2018 when you place a fraud alert, it will last one year, instead of 90 days. Fraud alerts will still be free and identity theft victims can still get an extended fraud alert for seven years.

**For Colorado and Illinois residents:** You may obtain additional information from the credit reporting agencies and the FTC about fraud alerts.

**Federal Trade Commission and State Attorneys General Offices.** If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your home state. You may also contact these agencies for information on how to prevent or avoid identity theft. **For Massachusetts residents:** You have the right to obtain a police report if you are a victim of identity theft. You also have a right to file a police report and obtain a copy of it.

**For Oregon residents:** You are advised to report any suspected identity theft to law enforcement, the Federal Trade Commission, and the Oregon Attorney General.
